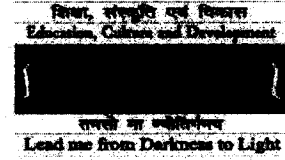

- The official will be relieved immediately and in any case within 3 days failing which he/she will be liable for disciplinary action, However if any official is working in Census duty, he/she shall not be relieved till the Census duty is accomplished.
- No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- No male teacher below the age of 50 years will be allowed to join in girls schools.
- If there is no vacancy in the destination school, the incumbent transferred shall re-join his/her previous place of posting and also report to the concerned branch/computer cell at HQ.  
If any discrepancy is noticed in the order in the violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- In case of mutual transfer, it is indicated that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.

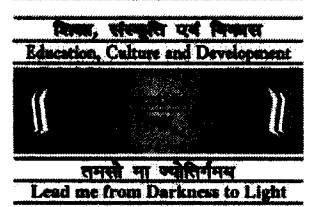

Sh. Joginder Singh, Mali-cum-Chowkidar, GHS Ludas [1244] (Hisar) is hereby given appointment as Chowkidar by way of transfer on provisional basis in the office of Director Secondary Education Haryana, Shiksha Sadan, Sector-5, Panchkula in the Grade Pay of Rs. 4440-7740+GP1300 plus usual allowances.

His pay will be fixed in the grade according to rules. He will also draw the usual allowances admissible to Government Servants of their categories from time to time.

His appointment in the Directorate of School Education Haryana, Panchkula will be on the following terms and conditions:-

1. His appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which he could continue to officiate in the Directorate of School Education Haryana, he will be sent to his parent office. It is, thus made clear to him that at present he has been offered temporary post.
2. In case at any stage, while he remains in temporary capacity and desire to resign his post he will be required to give one month's notice or forfeit in lieu thereof his salary including allowances for one month or the period by which the notice falls short of one month. He will give such a notice also in case, it is proposed to terminated his services for the reason other than that mentioned in clause (1) above.
3. His seniority amongst chowkidars/peons will be determined from the date he resume duty in the office.
4. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently no leave of any kind will be granted for perusing the higher studies.
5. He will remain on probation for a period of two years from the date of joining in the Department. The period of probation can be extended in accordance with the existing rules on the subject. For assessing his performance during the period of probation his work and conduct will be taken into consideration. If

his work and conduct during the probation is not found satisfactory, his services will be terminated forthwith without assigning any reason.

6. No TA/DA or joining time will be paid to him for joining this post.

If he is willing to accept the offer made on the above mentioned conditions, he may get himself be relieved and report for duty to the office of Director Secondary Education, Haryana, Shiksha Sadan, Sector-5, Panchkula within a period of 15 days from the issue of this letter.


