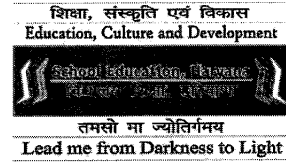

2. That they will be on probation period of one year.
3. That these promotion orders are without prejudice to the right of the seniors, if any, whose promotion cases may be decided at a later stage/ ant court case pending/ directions etc.

4. That their seniority in the Deputy Superintendent cadre will be determined later on as per instructions/Rules issued by the Govt./Department from time to time.

In case it transpires at a later stage that any employee does not fulfill the conditions as prescribed in the service rules, he/she shall be reverted / relieved to his original post immediately. After their posting all DDO are again directed to check the record that they fulfil the conditions/parameters.
6. They will have to join their duties at the place of new assignment within 15 days from the date of issue of promotion/posting orders failing which these orders shall stand automatically cancelled and they will forfeit their claim for seniority as Deputy Superintendent.
7. No TA/DA will be admissible to the official.
8. The official will be update their profile in MIS Portal when he/she join/relieve from his/her present working station and also supply the information to the Directorate within three days positively.
9. Concerned DDO is also directed to update and approved MIS data of the official at your own level within three days positively.
