Whereas Smt Sonu Yadav filed a civil writ petition no. 13242 of 2015 in the Hon'ble Punjab and Haryana High Court and prayed therein to consider her case for the promotion to the post of Lecturer (School Cadre) in Chemistry while considering the cut of date for acquiring the master degree as on the date of promotion or from the date of asking of particulars for the eligible candidates for the promotion i.e. 19.06.2015.

The said writ petition came up for hearing before the Hon'ble Court on 06.10.2015, wherein the following directions were issued:-

"I find the prayer made by learned counsel for the petitioner to be reasonable.

Accordingly, at this stage, without commenting on the merits of the case, the writ petition is disposed of with a direction to respondent No.5 to take decision on the objections dated 08.06.2015 (Annexure P-5) submitted by the petitioner by passing a speaking order and after affording opportunity of hearing to the petitioner, preferably within four months from the date of receipt of a certified copy of this order.


Needless to add that the decision so taken be communicated to the petitioner and if the decision is not to the satisfaction of the petitioner, she would be at liberty to challenge the same, in accordance with law".

That in compliance of the aforesaid directions of the Hon'ble Court, the relevant record pertaining to the claim of Smt. Sonu Yadav, Petitioner alongwith Annexure P-5 dated 08.06.2015 was examined and after careful consideration, it has been found that Smt. Sonu Yadav, working as Science Mistress at GSSS, Turkiawas, Tehsil and District Rewari completed her M.Sc degree in the year November 2014, but the cutoff date, consideration for the promotion of eligible candidates was determined by the competent authority as on 01.01.2014. Thus, the petitioner was not entitled to be considered with other eligible candidates on 01.01.2014, since she did not possess the requisite qualification on 01.01.2014 as she completed her M.Sc. degree only in

November, 2014. However, her case would be considered on merits along with others similar placed TGT's as per seniority list.

In view of the position explained above the case of the petitioner is not covered under the instructions issued by the department, the same is devoid of merits, thus her claim is hereby rejected.

I pass an order accordingly.

- In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective head of institution.**

Subject:- Regarding promotion from the post of Lecturer to the post of Principal.

Kindly refer to this office Memo No. 4/5-2013 HRG-I (2) dated 23.12.2013 and reminder dated 22.01.2015 on the subject cited above.


It is intimated that some posts of school Principals are available due to retirements. For smooth functioning of the administration, it has been decided to fill up these posts immediately. Earlier the department had invited the promotion cases of Lecturer Cadre upto 351 to 400. Due to availability of more posts of Principal, it is decided that the cases for promotion from Lecturer Cadre may be invited from concerned DEOs from seniority No. 351 to 400.

Therefore, you are requested to send the promotion cases of Lecturer Cadre from Seniority No. 351 to 400 as it stood on 07.11.2014. The cases be sent to this office within 7 working days positively through special messenger. Before forwarding the cases of Lecturers, the following point may also be taken into consideration:-

1. Personal file of the official along with last ten years ACRs record.
2. No complaint/no enquiry certificate duly counter signed by the concerned DEO.
3. Summary sheet of the official duly counter signed by the concerned DDO/DEO.
4. Also certified whether the official has charge sheeted under Rule-7/8 or not.

Note: All District Education Officers are directed to send complete personal files of the officials alongwith summary sheet duly counter signed by District Education Officer. Who have already sent the incomplete promotion cases they also directed to send the complete cases.

It is also mentioned here that you have sent the cases from 60 to 350 without the ACRs for the year 2014-15. You are therefore requested that the ACRs for the year 2014-15 from seniority No. 60 to 350 may be sent alongwith the above mentioned cases.
