Whereas, Smt. Indu Bala the then Principal, DIET Madina (Rohtak) now retired was charge sheeted under Rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide order dated 25.07.2015, wherein following charges were levelled against him :-

"That Smt. Indu Bala was transferred from DIET Madina to GGSSS, Bhalaut (Rohtak) vide order No. 4/5-2013 HRG-I(2) dated 31.12.2014, but Smt. Indu Bala, Principal has not joined at GGSSS, Bhalaut (Rohtak) till date and failed to comply with the order of the Government."

She submitted her reply on 27.08.2015 and denied all the charges leveled against her. She was also heard in person on 04.12.2015. During personal hearing, the incumbent submitted that as the transfer order was not clear, therefore, she referred the same back for correction of promotion and transfer orders of the directorate. Thereafter, her husband expired and she was mentally disturbed. On 05.08.2015, she received her transfer order dated 03.08.2015 and joined at GGSSS, Madina (Rohtak) on 06.08.2005. She never disobeyed the orders of higher authorities, thus, she is requested to drop the charge sheet being a widow, helpless and retiree.

After going through all the facts and circumstances of the case and reply of the delinquent, I have come to the conclusion that the reply of the delinquent is satisfactory, moreover the delinquent has already retired from service therefore, the charge sheet issued against her vide order dated 25.07.2015 under Rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 is hereby ordered to be filed as she has already been retired.

I pass an order accordingly.

A charge sheet No. 5/78-2015 HRME (5) 2785 dated 26.10.2015 under rule (8) was served upon to Sh. Satender Gautam, clerk, O/o BEO Nissing on the following lapses:-

“यह कि जिला शिक्षा अधिकारी करनाल द्वारा प्रस्तुत जांच रिपोर्ट दिनांक 29.7.2015 अनुसार पाया गया कि कर्मचारी द्वारा श्रीमती सुषमा कुश, ख0शि0अ0 निसिंग के हाजरी रजिस्टर के कालम में प्रश्न चिन्ह लगाया गया, जो कि उसके स्तर पर अनुशासनहीनता को दर्शाती है।”

Sh. Satender Gautam vide his letter dated 31.10.2015 furnished his reply to charge sheet. In his reply he has stated nothing on the charges levelled against him in the chargesheet and also levelled counter charges against Smt. Sushma Kush, BEO Nissing. He has stated that Smt. Sushma Kush BEO has many times asked him for signature on wrong paper and always misbehaves with staff. He has given the instance of Sh. Deepak Jain, Peon, against whom Smt. Sushma Kush, BEO has lodged FIR and put him upon in jail on the fake complaint of eve teasing and threatening.

The comments of DEO Karnal has been obtained on the reply to the charge sheet submitted by the official. The DEO Karnal vide letter dated 22.01.2016 has denied the facts stated by Sh. Satender Gautam in his reply to chargesheet. The DEO has also stated that Sh. Satender Gautam has not reply to charges of question mark in the column of BEO in attendance register. Further stated that Sh. Satender Gautam has admitted before him that in the column of attendance register of BEO, question mark was made by himself, which is violation of rules and shows the indiscipline of the official. The DEO has concluded that official is responsible for this lapse and recommended for disciplinary action.

1. **Sh. Kaptan Singh [067143], Driver, O/o District Education Officer, Rohtak [4086]** is hereby informed that it is proposed by the Governor of Haryana to take action against him under rule 7 of the Haryana Civil Services (Punishment and Appeal) Rules, 1987, on the grounds set out in the enclosed statement of charges. The charges are based on the statement of allegations appended thereto.
2. **Sh. Kaptan Singh [067143]** is hereby required to state in writing within a period of 15 days from the receipt of this memorandum by him whether he admits the truth of all, or any, of the charges, what explanation or defence, if any, he has to offer and whether he desires to be heard in person.
3. **Sh. Kaptan Singh [067143]** is hereby further informed that if for the purpose of preparing his written statement, he wishes to have access to the relevant official records, he should inspect the same in the office of the Director General, School Education, Haryana, Panchkula, on any working day after making prior appointment with him. It is, however, pointed out that only such documents will be shown to him as are in the possession of the Director General, School Education, Haryana, Panchkula and as are strictly relevant to the case. If in the opinion of the Government, it is not desirable in the public interest, to allow him access to any document, such access shall be refused. If, **Sh. Kaptan Singh [067143]** wishes to consult any other relevant record, which is not in the custody of the Director General, School Education, Haryana, Panchkula, it is for him to undertake its inspection. It is, however, made clear to **Sh. Kaptan Singh [067143]** that his failure to inspect the documents shall not constitute a valid ground for delay in the submission of his written statement and if the written statement is not received by the undersigned within the specified period, it shall be presumed that he has none to submit.
4. The written statement should be submitted direct to the undersigned.

Sh. Kaptan Singh, Driver while working in the office of District Education Officer, Rohtak has committed the following act of omissions and commissions.

Sh. Kaptan Singh, Driver after joining the duties on 30.05.2014 in the office DEO Rohtak applied for Station Leave on 02.06.2014 as well as Medical Leave stating the reason that he is not able to do any duties smoothly and to go to his District Sonepat for treatment and left the office without approval of Competent Authority. The DEO Rohtak vide letter No. E-2-2014/442-43 dated 03.06.2014 and No. E-2-2015/1071-72 dated 16.02.2015 requested the Civil Surgeon, Rohtak to fix a date for medical checkup from the Medical Board of the official under intimation to this office and copy of it was to Sh. Kaptan Singh, Driver, with the directions to appear before the Medical Board for medical checkup. But Sh. Kaptan Singh has never appeared before the Medical Board. Aforesaid letters were sent to Sh. Kaptan Singh, Driver at his home address.

Sh. Kaptan Singh neither appeared before the Medical Board for medical checkup as directed by the DEO Rohtak nor joined the duties in the office of DEO Rohtak.

Thus, Sh. Kaptan Singh, Driver is willful absent from duty since 02.06.2014.

The above act of misconduct on his part has been viewed seriously and warrant disciplinary action.

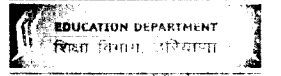

आरोप सूची विरुद्ध श्री अजमेर सिंह [22794], लिपिक, रा0वरि0मा0वि0 शिकारपुर (हिसार)।

श्री अजमेर सिंह ने दिनांक 2015 से 2016 तक रा0वरि0मा0वि0 शिकारपुर (हिसार) में लिपिक के पद पर पर कार्यरत रहते हुए निम्नलिखित अनियमितताएं की हैं:-

1. यह कि **श्री अजमेर सिंह, लिपिक** के विरुद्ध प्राचार्य, रा0वरि0मा0वि0 शिकारपुर (हिसार) द्वारा की गई शिकायत बारे उपायुक्त हिसार द्वारा जांच की गई। जिसमें उप-जिला शिक्षा अधिकारी, खण्ड शिक्षा अधिकारी, विद्यालय मैनेजमेंट कमेटी और गांव शिकारपुर के सदस्यों के समक्ष जांच की गई। जिसमें प्राचार्य व उक्त लिपिक का आपसी तालमेल सही नहीं पाया गया तथा **श्री अजमेर सिंह, लिपिक** का व्यवहार भी प्राचार्य व स्टॉफ सदस्यों के साथ सही नहीं पाया गया।
2. यह कि **श्री अजमेर सिंह, लिपिक** आदेश पुस्तिका में कटिंग करने का दोषी पाया गया। प्राचार्य द्वारा इस बारे स्पष्टीकरण मांगने एवं 5 दिन का वेतन रोकने उपरान्त भी रिकार्ड के साथ छेड़खानी करके अपनी उपस्थिति रिपोर्ट खण्ड शिक्षा अधिकारी को प्रस्तुत की। उप-जिला शिक्षा अधिकारी, हिसार द्वारा अपनी जांच रिपोर्ट दिनांक 09.12.2015 में **श्री अजमेर सिंह, लिपिक** का स्थानांतरण अन्य स्थान पर करने तथा इनके विरुद्ध अनुशासनिक कार्यवाही करने बारे रिपोर्ट प्रस्तुत की। उपरोक्त अनियमितताओं के कारण विद्यालय के छात्रों की पढ़ाई पर बुरा असर पडा तथा विद्यार्थियों द्वारा उक्त लिपिक के विरुद्ध गांव के सदस्यों, विद्यालय मैनेजमेंट कमेटी तथा जिला शिक्षा अधिकारी के समक्ष विरोध जाहिर किया गया। जिसकी वजह से विभाग की छवि धूमिल हुई तथा अनावश्यक तौर पर सरकार का समय बर्बाद हुआ।

इस प्रकार इन्होंने अपनी ड्यूटी के प्रति केवल लापरवाही बरती है जिसके कारण विभाग की छवि धूमिल हुई है, ऐसा करके **श्री अजमेर सिंह, लिपिक** ने सरकारी कर्मचारी (आचरण) नियम, 1966 के नियम 3 (i),(ii) तथा (iii) की उल्लंघना की है।

उपरोक्त अनियमितताएं **श्री अजमेर सिंह, लिपिक** के गम्भीर कदाचार को व्यक्त करती हैं जिनके कारण उन्होंने अपने आपको कडी अनुशासनिक कार्यवाही का पात्र बनाया है।

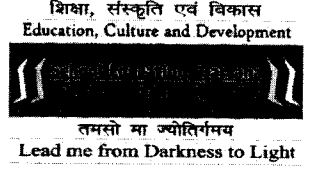
