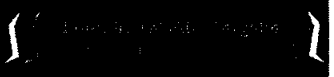

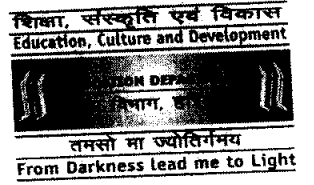

- 1. That she applied for No Objection Certificate to the Block Education Officer on 18.07.2012 for visiting Pakistan on the occasion of Shri Guru Nanak Dev Jayanti from 15.11.2012 to 12.12.2012, who is not competent authority to issue NOC. The permission to go to abroad is required from the Director Secondary Education. Without waiting she visited Pakistan which is against the Govt. rules/instructions for which she is liable for disciplinary action.**
- 2. That she applied for casual leave alongwith station leave on 23.11.2012 during the period 24.11.2012 to 06.12.2012 to the Headmistress Govt. High School Shekhupura Suhana, Karnal without obtaining the NOC from Head Quarter. She avail the leave and visited Pakistan for which she is liable for disciplinary action.**
- 3. That Smt. Baljit Kaur has violated the Govt. instruction and visit abroad without prior permission of the competent authority. Hence, she is violated the rule (3) of the employees conduct rule 1966.**

Smt. Baljit Kaur vide her letter dated 26.04.2016 furnished her reply to charge sheet. In her reply she stated that she applied through proper channel in the office of BEO Karnal on 18.07.2012 in advance and visited Pakistan on 15.11.2012 but her leave was never rejected by the office.

Smt. Baljit Kaur, clerk was given an opportunity of personal hearing on 29.07.2016 and during the course of personal hearing, she told that she went to Nankana Sahib (Pakistan) for visit as per wishes of her late husband. She had applied for NOC in time and even four months prior to date of visit through proper channel but no intimation of rejection was



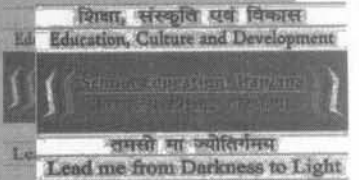
