
2. The case to award 3rd ACP GP 6000/- to the lecturers who were promoted as such before 01-01-2006 from the post of Master was forwarded to the Finance Department for clarification as to whether the incumbents who have already got three financial up-gradations may be awarded the 3rd ACP GP Rs.6000 or otherwise. The Finance Department have tendered its clarification as under:-

"Administrative Department is advised the incumbent was granted the ACP of the Grade Pay Rs.5400/- alongwith increment, whereas he had already been granted two fixation benefit as on 01-11-1996 and 20-10-2004. The increment granted on 01-11-2006 may be withdrawn. Further, he can be considered for 3rd ACP of the Grade Pay 6000/- w.e.f. 04-03-2014".

You are, therefore, requested to take necessary action in view of above clarification as per law. Then the case may be re-submitted to the Directorate.
