

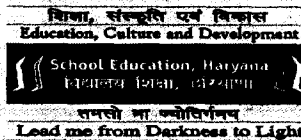

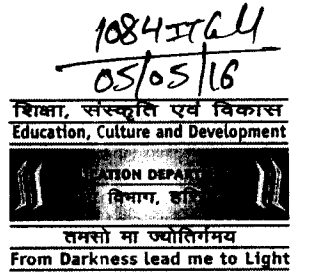

OFFICE ORDER

Order No. 22/104-2015 HRME (4)

The Hon'ble High Court in CWP No. 3306 of 2016 -titled as Rajdeep V/s State of Haryana and other vide order dated 18.02.2016 has disposed of writ petition with a direction to respondent no. 2 and 3 to take a decision on the representation dated 06.01.2016 (Annexure-P-9) submitted by the petitioner. He further submitted to get posted in the office of Transport Commissioner, on transfer basis but he failed to give reason of getting transfer to Transport Department as he wanted to be posted in RTA office.
