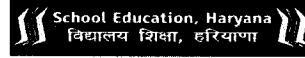

### ADMISSIONS & FUNCTIONING OF SCHOOL NOT ALLOWED WITHOUT RECOGNITION

In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

The permission to add new proposed classes for higher stage is only 'In-principle' approval of the Education Department to allow applicant to initiate steps and provide infrastructure to the new proposed classes of higher stage.

Students should not be admitted only on this permission without getting recognition. The recognition will be granted R.T.E. Rules-12 Appendix-II by the Department on fulfillment of prescribed norms as provided in Haryana School Education Rules-2003, in the interest of safety, health and welfare of students and other requirements.

\* The managing committee shall abide by the provisions of Haryana School Education Rules 2003 (amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provisions of the rules.



Om Parkash, Water Carrier/Class-IV, office of District Education Officer, Sirsa was promoted vide Office Order No. 2/1-2011 HRME (5) dated 08-07-2013 from General Category to the post of clerk and posted in office of District Education Officer, Sirsa with the terms and condition that this promotion is subject to the modification and cancellation, if in any case discovery of any defaulted data is found, his promotion orders will stand cancelled without any notice. Thereafter, on receipt of CWP No. 19371 of 2014-Kailash Chander Vs. State of Haryana and CWP No. 16127 of 2015-Iqbal singh Vs. State of Haryana, it came to the notice of the Department that Sh. Om Parkash, Class-IV was promoted to the post of clerk w.e.f. 08.07.2013 on the recommendation of District Education Officer, Sirsa without verifying the record/sinority. The matter was reconsidered by the Department and it has been found that Sh. Om Parkash is not eligible for promotion as he was transferred at BEO Dabwali from BEO Sirsa vide order dated 13.03.2008 at his own request. However, as per the condition of the promotion from Class-IV to the Post of Clerk, it was specifically mentioned that the candidate of General Category who have passed Matric, as qualification and appointed on regular basis upto 31.12.1995 and Schedule Caste category official appointed upto 31-12-1998 were eligible for promotion, and as per record, available in IT Cell of this Department, his seniority was to be counted w.e.f. 18-03-2008 and the cut-off date was fixed as 31-12-1995 for General Category. Therefore, as per cut-off date, he was not eligible for promotion to the post of clerk. The detail of his service record is as under:-

2. Date of Regularization as Class-IV - 14.02.1996
3. Transfer from BEO Sirsa to BEO Dabwali

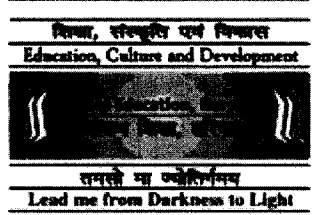


