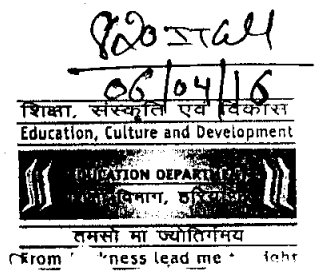

Whereas Sh. Attar Singh, Class-IV O/o DEO, GSSS Rohtak is a General Category candidate. On receipt of CWP No. 17246 of 2014 titled Attar Singh Vs. State of Haryana, his case was examined. As per the condition of the promotions from Class-IV to the Post of Clerk, it was specifically mentioned that the candidate of General Category who have passed Matric, as qualification and appointed on regular basis upto 31.05.1997 and Schedule Caste category official was appointed upto 31-12-1998, are eligible for promotions. As per record, available in IT Cell of this Department, his seniority was to be counted w.e.f. 07.07.1997 as he was transferred from GHS Ghusani (Bhiwani) to GHS Narayangarh (Rohtak) vide order No. 4/31-1996 ME (8) dated 12.06.1996. The detail of his service record is as under:-

1. Date of appointment as a Class-IV on regular basis - 18.02.1994
2. Transfer from GHS Ghusani (Bhiwani) to GHS Narayana (Rohtak) vide order No. 4/31-96 ME (8) - 07.07.1997

So as per his service record, the seniority of the employee is to be reckoned from 07.07.1997 for his promotion to the post of Clerk.

Therefore, after perusal of the facts of the case, he is not eligible for promotion from class-IV to the post of clerk. The case of the petitioner is liable to be rejected.

ORDER

Memo No. 36/1-2014 PS (3)

Whereas, following a complaint, a show cause notice under Rule 43 of the Haryana School Education Rules, 2003 amended in 2007 was issued on 13.05.2015 to Nav Jyoti Shiksha Samiti, Birohar (Jhajjar) for withdrawal of recognition of their school namely Nav Jyoti Sr. Sec. School, Birohar, district Jhajjar. This school was granted recognition upto 10+2 level under the Haryana School Education Rules, 2003 (hereinafter referred to as Rules) by Director Secondary Education, Haryana vide order No. 14/73-2007PS(1) dated 10.9.2008 issued on 15.9.2008 on the application of Nav Jyoti Shiksha Samiti, Birohar (Jhajjar).

At the outset, the brief facts of the case are that a complaint was received against Nav Jyoti Shiksha Samiti, Birohar (Jhajjar) that it has got permanent recognition of the school on the basis of false documents regarding the school building in which residential building is existing and the distance of playground is not as per norms. In addition to this, the school building of 9th to 12th classes is also at a distance of about 2 K.M. from the Middle school building. The land where the Middle school is established is also not as per Rules/norms. The complainant had requested to cancel the permanent recognition/permission of the school.

The complaint was forwarded to the District Education Officer, Jhajjar to conduct the inquiry and submit inquiry report along with comments. Accordingly, the D.E.O. Jhajjar submitted inquiry report on 24.03.2015 to this Directorate whereby the allegations levelled by the complainant were found to be true.

Therefore, under the Rule 43 of the Rules, the school management i.e. the society was issued a notice of showing cause as to why the recognition/N.O.C. granted to their school upto 10+2 level may not be withdrawn/suspended from the next academic session 2016-17. The management/society was also directed to submit reply/representation, if any, it wants to submit, should reach in the department within a period of 30 days.

In response to the show cause notice, no reply/representation, to controvert the allegations levelled by the complainant was submitted by the society within the stipulated time of 30 days granted to society. Ultimately, the

recognition of the school of the society was withdrawn by the under signed vide order dated 25.07.2015 w.e.f. 01.04.2016.

Thereafter, vide application dated 24.08.2015, Sh. Sant Lal, Principal of the school has prayed that the recognition of their school may not be withdrawn and their submissions may be considered sympathetically.


The applicant was afforded an opportunity of hearing on 11.03.2016, following which, he was present on the date of hearing. During the course of hearing, he submitted that they are four brothers and the land is a mustarka khewat. The land has not been partitioned and all the four brothers are owners in possession of the land and the same has been leased upto 2037. The lease of the land has not been cancelled and the building of the school is at the distance of 341 feet from the playground. In the end, the applicant denied all the allegations levelled upon him and he requested to review order dated 25.07.2015 whereby the recognition of their school was withdrawn.

Whereas, as per the provisions of the rules, every individual, association of individuals, society or trust desirous to establish a school submits an undertaking at the time of getting permission/recognition that it will abide by all the provisions of Act and Rules framed there under and the instructions issued by the department from time to time.

As a sequel of above findings, I have come to the conclusion that the society has got the recognition of Nav Jyoti Sr. Sec. School, Birohar (Jhajjar) by fraud on the basis of misrepresentation and concealment of material facts from the department. The Society also submitted an affidavit/undertaking to this effect that it will abide by the provisions of Act and Rules but as per the inquiry report it was found that it has misled the department by concealing the material facts regarding the building where the school is established. In the undertaking submitted by Manager of the society wherein, it was submitted that the school building is sufficient in all respects whereas in the inquiry report, it has been found that the Manager of the society has concealed the material fact that the school building is also being used for residential purposes. The building in possession of the school, as per version of the complainant, is situated at more than two different places. Thus, by doing so the society has violated the provisions of Rule 43 Haryana School Education Rules, 2003 amended from time to time. Moreover, no new fact has been submitted by the applicant and he has reiterated the same version. Hence, the order dated 25.07.2015 passed by the undersigned does not suffer from any

infirmary and the same is not liable to be reviewed in any way. The application of the applicant society deserves to be rejected.

The application/representation of the applicant is hereby rejected in the aforesaid terms. The parties be informed accordingly.




