

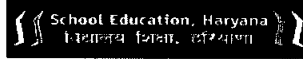

Whereas Sh. Ved Pal has filed CWP No. 21878 of 2012, in the Hon'ble Punjab & Haryana High Court for quashing the impugned order dated 11.10.2012 (Annexure P-4) whereby the request for the withdrawal of voluntary retirement of the petitioner has been declined and to set aside the order dated 08.08.2012 (Annexure P-2) vide which the petitioner has been allowed to retire voluntary from service w.e.f. 31.08.2012 and further to issue a writ of mandamus directing the respondents to allow the petitioner to be continued in service with all consequential benefits.

This case came up of hearing on 09.12.2015 and disposed of with the following directions:-

***"Consequently, while setting aside order dated 11.10.2012 (Annexure P-4) the petitioner is granted another opportunity to make an application to the respondents in terms of sub-rule (4) of Rule 5.32 of the Punjab Civil Services Rules, Volume II, as applicable to the State of Haryana, requesting them to revoke his earlier request seeking voluntary retirement. If the appropriate authority is satisfied and convinced with the reasons that may be assigned by him an appropriate order would be passed within a period of three months from the date of receipt of representation/application by the petitioner. If the request of the petitioner is accepted, he would be granted the benefits notionally only, though with the benefit of seniority and pay fixation".***

In view of the above directions of the Hon'ble High Court, the petitioner was heard in person on 26.04.2016. During the course of hearing petitioner has produced a copy of the judgment of Hon'ble Supreme Court, the extract of which is follows as under:-

***"Withdrawal of application after acceptance:-*** The Government employee applied for voluntary retirement on giving three months notice and the same was accepted. But after acceptance, he sought for withdrawal of voluntary retirement prior to expiry of period of notice but the same was refused. Against such refusal he sought for judicial remedies. However, when the SLP before the Supreme Court was pending the Government employee retired on superannuation. In view of the above circumstances the Supreme Court has held that notwithstanding that the Government employee at the relevant time was entitled to withdraw such application for voluntary retirement, yet as the employee has in the meantime retired on superannuation there is no question to grant him any relief as granting any relief in this case would be futile. **Balbir Singh Negi v Union of India** 1996(8) SCC 283; 1996(2) SLR 614 1996(2) RSJ 618, 1996(2) SCT 706"

However, this decision clearly indicates that even after acceptance the employee has the right to withdraw the prayer for voluntary retirement before the expiry of the notice period, because before it takes effect he can apply for withdrawal of voluntary retirement. This is made clear by the Supreme Court in **J.N. Srivastava v Union of India** [1998(9) SCC 559; 1998 SCC (L&S) 1251] where the Supreme Court has clearly

held that even after acceptance of voluntary retirement, the employee has the right to withdraw it prior to expiry of the period of notice."

On the basis of the facts in the file, it is clear that vide application dated 30.04.2012, the petitioner applied for voluntary retirement w.e.f. 31.08.2012. His request was accepted and he was permitted to retire voluntarily w.e.f. 31.08.2012 vide order dated 27.07.2012. However, in the morning of 31.08.2012, the petitioner made another application for withdrawal of his request for voluntary retirement, which ought to have been accepted in view of the aforesaid observations of Hon'ble Supreme Court of Haryana, but the same was rejected.

Keeping in view the facts and circumstances of the case, now the request of the petitioner for withdrawal of his request for voluntary retirement is hereby accepted. However, no arrear of pay will be given, he will be entitled only for notional benefits of seniority pay fixation and he will have to deposit all the retiral benefits with interest in the Govt. Treasury.

I pass an order accordingly.


