Terms and Conditions:-

1. The benefit of promotion will be admissible to the above official w.e.f. 10.2.2014 only for the purpose of notional pay fixation and seniority and actual financial benefits will be admissible from the date she joins duties as Headmistress, High School.
2. The newly promoted Headmistress will have to join duties immediately but not later than 20.1.2016.
3. If the integrity of the promotee(s) is found doubtful he/she will be reverted without giving any notice.
4. The inter-se-seniority of the promotee(s) is subject to the claim of his/her seniors, who have not been promoted in these order due to various reasons.
5. If any official is found senior to the above official(s) at any stage due to refixation of his/her seniority in his/her feeder cadre, the junior most promote (s) shall be reverted without giving any notice.
6. If at any stage it is found that any official has been promoted in these orders inadvertently who was otherwise actually not eligible for promotion he/ she will be reverted to his/her feeder cadre original post without any notice.
7. That this promotion is subject to the condition that all the particulars and data supplied by the concerned employee and field offices are correct. In the event of any information found to be factually incorrect, erroneous or misrepresented, the promotion so granted shall be withdrawn forthwith without affording any further opportunity.
8. If the seniority of any official is fixed later on in accordance with the instructions contained in Haryana Govt. letter No. 22/73/92-3GS-III, dated 14.10.1999, he/she will be reverted without any notice.
9. That she will remain on probation for a period of one year which can be extended if her services are not found satisfactory as per the rules.

10. The promotee will report to the DEO concerned who is competent to allow him/her to join duty as High School Headmistress.
11. The District Education Officer concerned shall personally ensure the following:-
- In case the promotee had not joined on promotion as Elementary School Headmaster, he/she will not be allowed to join as High School Headmaster.**
 - That these promotion orders are being issued against vacant post. In case the promotee finds that the post against which he/she is being appointed is not vacant in the school, he/she is advised to report in the Directorate through the concerned District Education Officer so that he/she can be adjusted at some other place.
 - No Headmaster is to be posted at any urban place. In case any urban station has been allotted, the DEO concerned will ensure that such newly promoted Headmaster has rendered atleast 15 years rural service during his/her service career.
 - That this promotion is subject to the condition that there is no adverse remark pertaining to integrity in the ACRs of the newly promoted Headmistress during the last ten years.
 - No complaint/ enquiry is pending against her.
 - That the concerned District Education Officers will not allow the promotee to join his duties if any complaint/enquiry under Rule-7 and 8 of the Haryana Civil Services (Punishment & Appeal) Rules-1987 is pending against him/her.




