- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.

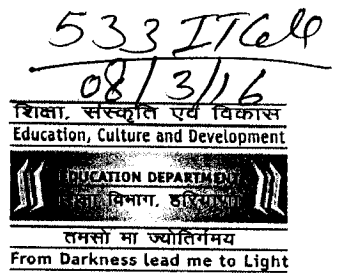

OFFICE ORDER

Whereas Sh. Mahavir Parsad, Peon/Class-IV O/o DEO, Sirsa being a Schedule Caste Category candidate was promoted vide Office Order No. 2/1-2011 HRME (5) dated 07-04-2011 to the post of clerk and was posted in GHS Khai Shergarh (Sirsa) O/o DEO, Sirsa with the terms and condition that this promotion is subject to the modification and cancellation, if any defaulted data is found, then his promotion orders will stand cancelled without any notice.

As per the condition of the promotion from Class-IV to the Post of Clerk, it was specifically mentioned that the candidate of General Category those who have passed Matric, as qualification and appointed on regular basis upto 31.12.1995 and Schedule Caste category official appointed upto 31-12-1998 were eligible for promotion.

Thereafter, on receipt of CWP No. 1030 of 2013- Rajender Vs. State of Haryana. It came to the notice of the department that Sh. Mahavir Parsad, Peon/Class-IV promoted was as a clerk w.e.f. 07.04.2011 which was done without verifying the record/ seniority and on the recommendation of DEO Sirsa. Now, the matter was reconsidered by the Department and it has been found that Sh. Mahavir Parsad was not eligible for promotion as you were transferred from Municipal Corporation, Haryana to Education Department, Haryana via Sub Divisional Education Officer vide order E-I-99/6 dated 06.01.2000 and joined on 07.01.2000 and hence his seniority was to be counted w.e.f. 07-01-2000. The detail of his service record is as under:-

2. Date of Regularization as Class-IV - 29.05.1998
3. Transfer from Municipal Corporation Haryana to Education Department Haryana vide sub Divisional Education Officer order NO. E-1-99/6 dated 06.01.2000 & Date of Joining - 07.01.2000

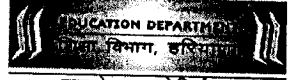

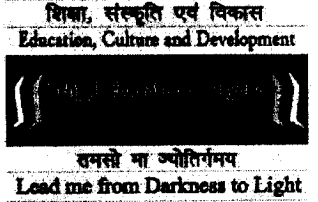


