In view of the above, a show cause notice was issued to him on 22.01.2016 that why he may not be reverted back on the substantive post as Class-IV employee and in this regard, no reply has been received in this Directorate till 07.02.2016.

Therefore, after perusal of the facts of the case, being a competent authority, I confirm the show cause notice dated 22.01.2016 and Sh. Raghubir Singh is reverted back to his substantive post as class-IV employee w.e.f. 23.03.2006.

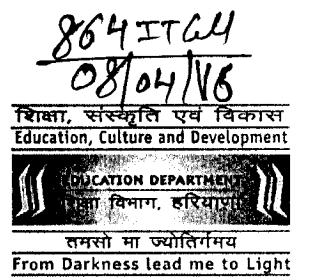

As per record, available in IT Cell of this Department, his seniority was to be counted w.e.f. 07.07.1997 as he was transferred from GHS Ghusani (Bhiwani) to GHS Narayangarh (Rohtak) vide order No. 4/31-1996 ME (8) dated 07.07.1997. The detail of his service record is as under:-

2. Transfer from GHS Ghusani (Bhiwani) to GHS Narayana (Rohtak) vide order No. 4/31-96 ME (8) - 07.07.1997

So as per his service record, the seniority of the employee is to be reckoned from 07.07.1997 for his promotion to the post of Clerk.

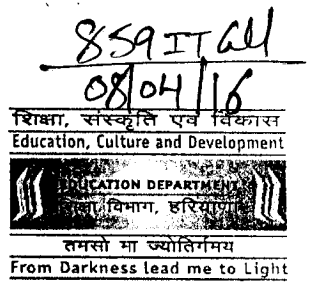

The Hon'ble High Court in CWP No. 17076 of 2015-titled as Udai Bhan Vs State of Haryana and other vide order dated 18-08-2015 had passed direction to consider the claim of the petitioner. The operative part of the judgement/order is reproduced as under:-

"The petitioner prays for step up of his pay and in this regard he has submitted a legal notice which is on record as Annexure P-2.

After hearing the learned counsel for the petitioner and nothing the grievance as expressed in the petition, I am of the considered view that this petition needs to be disposed of at this stage with a direction to the respondents to consider the claim of the petitioner as contained in the legal notice dated 30.6.2015 (Annexure P-2) by passing a speaking order within a period of two months from the date of receipt of certified copy of the order. Ordered accordingly."

In compliance of the order the case of the petitioner was examined on merits by the office. The petitioner in his legal notice dated 30.06.2015 (P-2), has requested for step up his pay alongwith all consequential benefit at par with the pay of his counter part junior colleague Sh. Kulbir Singh, Lab Attendant GSSS Sorkhi (Hissar), who is drawing pay higher then him in pursuance of order no. 13/30-2011 HRME (4) dted 21.03.2012.

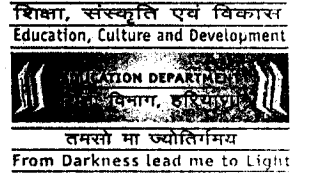
The brief facts of the case are that "Sh. Udai Bhan joined as Peon on 06.07.1983 in GHS Guhna, Sonapat in the pay scale of Rs. 750-940. Later on he was transfer to GGSS Dhani Mahu, Bhiwani on 18.11.1987. He was promoted as Lab Attendant vide office order dated 04.11.1997 and he joined on the post of Lab Assistant on 06.11.1997.

Sh. Kulbir Singh, joined as peon on 03.08.1983 in the pay scale of Rs. 750-940 in G.H.S, Mehanda (Hisar). He was provisionally promoted as Lab Attendant vide DEO Hisar office order no. Steno/2001/219 dated 12.03.2001 in the pay scale of Rs. 3050-4350 and posted in GSSS Sorkhi, Hissar.

The petitioner was heard in person on 16.02.2016, he during the course of hearing, submitted that he may be step-up at par with Sh. Kulbir Singh, who was upgraded with Sh. Karambir.

The office submitted that Sh. Kulbir Singh and three others filed the CWP No. 4797 of 2011 titled Ram Chander & others V/s State of Haryana and others for step up his pay at par with his junior counter part of reserve category employee. The Hon'ble Punjab and Haryana High Court dispose of the writ petition vide order dated 17.03.2011 with the direction to the respondents to dispose of the legal notice as expeditiously as possible. Accordingly, the case of Sh. Kulbir Singh, General Category to step up at par with junior colleague Sh. Karambir of reserve category was examined and deemed date of promotion was granted to Sh. Kulbir Singh, by step up his pay w.e.f. 31.01.1992 (notional) at par with Sh. Karambir of reserve category, vide office order no. 13/30-2011 ME (4) dated 21.03.2012.

Thus, Sh. Udai Bhan who promoted and join as Lab Attendant on 06.11.1997 is junior to Sh. Kulbir Singh, who was allowed deemed date of promotion as Lab Attendant w.e.f. 31.01.1992 (notional).

Now coming to the contention of the petitioner for grant of step up his pay at par with pay of his counterpart junior colleague Sh. 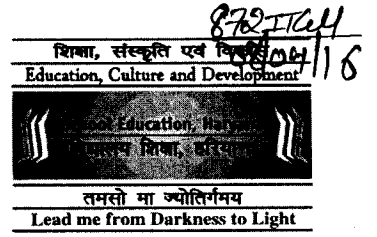

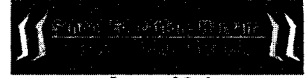
