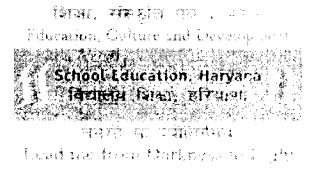

His reinstatement is without prejudice to the disciplinary/judicial action pending against him and also without prejudice to the decision that may be taken regarding the period for which he remained under suspension.


