

That Sh. Dalbir Singh, Clerk, working in the GSSS Isharwal (Bhiwani) for the last 15 years, has been failed to report to the Principal/Higher Authority regarding absence of Sh. Sube Singh, Math Master since 12.11.2001, which shows the negligence on his part to perform his duties.

Smt. Santosh Hooda, DEO, Hisar was appointed as Enquiry Officer to conduct the departmental enquiry vide this office order No. 5/98-2015 HRME (3) dated 23.06.2014. The enquiry officer submitted her enquiry report vide no. Steno/2016/4332 dated 08.08.2016 at which charges levelled against Sh. Dalbir Singh, Clerk, GSSS, Isharwal was proved on receipt of the enquiry report office examine the report and submitted to the competent authority in tabulated form.

Sh. Dalbir Singh, clerk was given an opportunity of personal hearing on 17.11.2016 and during the course of personal hearing, he stated that he informed Headmaster/DDO, Sh. Karan Singh, Sh. Ishwar, Principal, Sh. Raghubir, Sh. Ram Chander, Sh. Bhagirath and Sh. Arun Kumar verbally only regarding absent of Sh. Sube Singh, Math Teacher, he further stated that he never gave in writing to anybody.

After careful consideration of reply to the charge sheet and submission made during personal hearing granted to the official on 17.11.2016 and keeping in view, seriousness of case that teacher (Sh. Sube Singh) remained absent from this school for 14 years and school Principal/Clerk never informed the Headquarter for absent


