



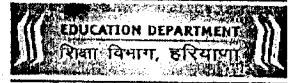

Whereas Sh. Amar Lal, Sweeper-cum-Chowkidar/Class-IV O/o DEO, Jind being a Schedule Caste Category candidate was promoted vide Office Order No. 2/1-2011 HRME (5) dated 06-07-2012 to the post of clerk and was posted in GHS Ghaso, Jind with the terms and condition that this promotion is subject to the modification and cancellation, if any defaulted data is found in then his promotion orders will stand cancelled without any notice.

As per the condition of the promotion from Class-IV to the Post of Clerk, it was specifically mentioned that the candidate of General Category those who have passed Matric, as qualification and appointed on regular basis upto 31.12.1995 and Schedule Caste category official was appointed upto 31-12-1998 were eligible for promotion.

Thereafter, on receipt of CWP No. 9525 of 2013- Suresh Vs. State of Haryana. It came to the notice of the department that Sh. Amar Lal, Class-IV had been promoted w.e.f. 08.07.2013 without verifying the record/ seniority and on the recommendation of DEO Jind. Now, the matter was reconsidered by the Department and it has been found that Sh. Amar Lal was not eligible for promotion as he was transferred from GHS- Kirarod, Jind to GHS, Budain, Jind vide order dated 24.07.2008 on his request as per record, his seniority was to be counted w.e.f. 24-07-2008 as per of his service record which is as under:-

1. Date of appointment as a Sweeper-cum-Chowkidar/Class-IV at GHS Kakrod (Jind) - 23.12.1997
2. Date of Regularization as Class-IV - 23.12.1997
3. Transfer from GHS Kakrod [1712] (Jind) to GHS Budain [1712] (Jind) on - 24.07.2008

So as per his service record, the seniority is to be reckoned from 24.07.2008 for promotion to the post of Clerk as a Schedule Caste candidate.

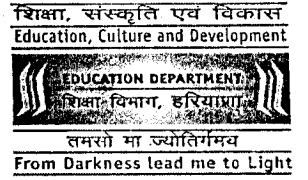
