Smt. Poonam Anand, Clerk, DIET, Pali (Faridabad) was Charge Sheeted under Rule-7 of Haryana Civil Services (Punishment and Appeal Rules-1987) vide order No. 5/48-2011 HRME (1) dated 18/04/2013 for remaining absent from duty from a long time, wherein following charges were leveled against her:-

1. यह कि आप दिनांक 03.04.2001 से 29.06.2001 तक सक्षम अथोरिटी की स्वीकृति/अनुमति के बिना अवैतनिक अवकाश पर रही जबकि प्राचार्य डाईट पाली फरीदाबाद द्वारा आपको दिनांक 03.04.2001 से 28.11.2001 तक का कोई अवकाश स्वीकृत नहीं किया गया था लेकिन आपने सेवापंजी में इसका इन्द्राज किया हुआ है जिस पर प्राचार्य के हस्ताक्षर नहीं है।
2. प्राचार्य डाईट पाली ने उनके पत्र क्रमांक ई-1/2001/507, 525, 109 दिनांक 07.06.2001, 05.07.2001 व 05.10.2001 के अनुसार श्रीमति पूनम आनन्द को कार्यालय में हाजिर होने के लिए पत्राचार किया लेकिन लिपिक कार्यालय में हाजिर नहीं हुई।
3. यह कि दिनांक 13.11.2001 को आपकी दीर्घकालीन तथा बिना अनुमति/स्वीकृति के कारण अनुपस्थिति में श्रीमति नेमवती को आपके स्थान पर नियुक्त किया गया। इसके बाद आप द्वारा दिनांक 10.12.2001 के पश्चात् ना तो डाईट पाली तथा न ही जिला शिक्षा अधिकारी, फरीदाबाद से कार्यग्रहण करवाने बारे अनुरोध/पत्र व्यवहार किया तथा न ही व्यक्तिगत रूप से डाईट पाली तथा जिला शिक्षा अधिकारी, फरीदाबाद के कार्यालय में उपस्थित हुई तथा दिनांक 13.11.2001 से 30.08.2011 लगभग 10 वर्ष तक निदेशालय से आप द्वारा कोई पत्र व्यवहार नहीं किया गया। अतः आप दिनांक 13.11.2001 से 30.08.2011 तक अपनी इच्छा से अनुपस्थिति रही।

Smt. Poonam Anand submitted reply of the above charge sheet on 07/05/2013 and denied all the charges levelled against her. Sh. V.G. Goel, HCS Retd. was appointed as regular Inquiry Officer. The Inquiry Officer submitted its report on 26/09/2013 with the following conclusions:-



for Personal Hearing. Therefore, Smt. Poonam Anand was again granted the opportunity of personal hearing on 06/01/2015. During the course of hearing, delinquent official has submitted no new facts and the compulsory retirement order were confirmed by Additional Director Administration-I vide order dated 31/03/2015 issued on 15/07/2015 and it was decided not to give any benefit for absent period i.e. 13/11/2001 to 30/08/2011.

The delinquent preferred and appeal dated 25/08/2015 against the above orders. Accordingly, an opportunity of Personal Hearing was granted to the delinquent on 21/12/2015. During the course of hearing she has submitted no new facts.

After going through the relevant record of the case, Inquiry Report, reply of delinquent, the appeal of Smt. Poonam Anand, Clerk is dismissed being devoid of any merits.

Order No. 10/6-2008 HRG-I (2)

Dated, Chandigarh the 8-1-16

Sh. Moola Ram Sharma the then District Education Officer-cum-District Elementary Education Officer, Yamuna Nagar was charge sheeted vide order dated 17.12.2008 under Rule-7 of Haryana Civil Services (Punishment and Appeal) Rule, 1987 for committing irregularities while purchasing CFL Tubes and Ceiling Fans on the basis of preliminary enquiry conducted by Sh. Roop Singh the then Additional Director O/o Director, Elementary Education and the following charges were levelled against him :-

1. यह कि श्री मूला राम द्वारा 5208 सी0एफ0एल0 बल्ब तथा 1700 पंखों की खरीद में अनियमितता करना।
2. यह कि श्री मूला राम द्वारा महालक्ष्मी ट्रेडिंग कम्पनी से खेतान पंखे की कोटेशन लेकर जोल्टा कम्पनी के पंखे खरीदना।
3. यह कि श्री मूला राम द्वारा जोल्टा कम्पनी के पंखों पर भी खेतान कम्पनी की लोहे की जगह कागज की स्लिप चिपकना तथा ये पंखे जोल्टा कम्पनी की बजाये किसी लोकल कम्पनी के होना।
4. यह कि श्री मूला राम द्वारा पंखे खरीद कमेटी को पंचकूला की फर्म से पंखे खरीदने के लिए 705500/-रु० की राशि मिलिभगत करके एजेंसी को अधिक राशि देना और 28220/-रु० का फालतू टैक्स तथा कुल 7,33,720/-रु० की राशि का भुगतान करना।
5. यह कि श्री मूला राम द्वारा 15 वाल्ट की सी0एफ0एल0 ट्यूब्स की खरीद ओसराम कम्पनी (अम्बाला) से 130/-रु० की दर से खरीदना जबकि बजाज कम्पनी की 15 वाल्ट की सी0एफ0एल0 ट्यूब्स की दर 75/-रु० दर होना तथा मुन्ना लाल तथा पूजा, फिलिप्स तथा बजाज की यमुनानगर में दो प्रसिद्ध एजेंसियों से कोई कोटेशन न लेना।
6. यह कि श्री मूला राम द्वारा बिजली उपकरणों की खरीद के लिए विभाग द्वारा जारी की गई स्पेशिफिकेशन जिसके अनुसार 20 वाल्ट की सी0एफ0एल0 ट्यूब्स के बजाये अपने स्तर पर 15 वाल्ट की ट्यूब्स खरीदना।
7. यह कि श्री मूला राम द्वारा ओसराम ट्यूब्स पर मुद्रित रेट के उपर कागज की पर्ची चिपकी पाई जाना जिसपर रेट्स तथा उत्पाद तिथि में भिन्नता पाई जाना।
8. यह कि श्री मूला राम द्वारा मलिक सेल्स तथा चौधरी एण्टरप्राइजिज जो किसी कम्पनी के प्राधिकृत डीलर नहीं है और न ही थोक विक्रेता। इन दोनों स्थानीय रिटेलरों के नाम मात्र कोटेशन लेना जोकि दिनांक 01.10.2007 को माल सप्लाय के बाद (28.09.2007) प्राप्त करना।
9. यह कि निरीक्षण कमेटी द्वारा माल खरीदने से पूर्व तथा बाद में माल का निरीक्षण न करवाना।
10. यह कि श्री मूला राम द्वारा जोल्टा कम्पनी के 1700 पंखों की खरीद में 733720/-रु० तथा 5208, ओसराम कम्पनी की ट्यूब्स की खरीद में टैक्स सहित 297897/-रु० अर्थात कुल 1031617/-रु० की सरकार को वित्तीय हानि पहुंचाना।

That in response to the above charges, Sh. Moola Ram failed to submit his reply within stipulated period. Consequently, Sh. O.P. Gupta, Distt. & Sessions Judge (Retd.) was appointed as enquiry officer vide office order No. 10/6-2008 HRG-I (2) dated 01.10.2009 to conduct the regular departmental enquiry against Sh. Moola Ram Sharma. Enquiry Officer submitted his enquiry report on 26.10.2010 and concluded that charge No. 1 & 10 are taken jointly and held that irregularities were committed in the matter of 5208 CFLs, 1700 Fans and a loss of Rs. 7,33,720/- was caused to the state exchequer.

That with regard to the charge No. 9, it is observed that no inspection of the goods were carried out and the alleged inspection by two members of the purchase

committee on 08.10.2007 was only superficial. Remaining charges were also proved against the delinquent partly.

After taking cognizance on the report of the Inquiry Officer and as per requirement of the Rule 7(6) of the Haryana Civil Services (Punishment & Appeal) Rules, 1987, a copy of the inquiry report was sent to said incumbent on 20.12.2010 to make a written representation in support of his defence, if he so desires, within a period of one month.

The said representation of Sh. Moola Ram Sharma was received in this office on 10.03.2011, wherein he requested that an extension of one month beyond the expiry date already fixed for the submission of the reply may kindly be granted so that he may be in a position to defend his case suitably in the interest of the natural justice. The request of the petitioner was declined since he was intentionally delayed the matter pertaining to the year, 2007.

On the basis of charges levelled against the delinquent, reply thereof, report of Inquiry Officer and after going through all facts and aspects of the case, it is established beyond doubt that the delinquent committed various irregularities at the time of purchasing the material and caused huge loss to the public exchequer.

In view of the above, the following punishment be inflicted upon Sh. Moola Ram Sharma:-

1. Recovery of Rs. 7,33,720/- from gratuity and further, if needed, from the leave encashment.
2. Cut in pension to the tune of 5% for the whole life.

The approval of Haryana Public Service Commission as per requirement of rule 2.2 (B)(4) of Punjab Civil Services rule Vol. 2 as applicable to Haryana has been obtained on 09.11.2015.

I pass an order accordingly.
