ORDER

In exercise of the powers conferred upon me under rule 34(1) of Haryana School Education, Rules, 2003, the sanction is hereby accorded for permanent recognition to **K.M. Public Sr. Sec. School, Vill. Mandkola (Palwal)** run by Managing Committee, **K.M. Memorial Shiksha Samiti, Vill. Mandkola, Teh. Hathin, Distt. Palwal**, for classes from 11 to 12 in subjects of (Science Only) under BOSE pattern with effect from 01.04.2016 under the following terms and conditions:-

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. however, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth or any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or any existing class during the academic session without the prior approval of the appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student fo elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amnedments it any thereafter. The Managing shall be liable for diciplinary action in case of violation of any provision of the rules.

Civil Writ Petition No. 19991 of 2015, titled as Jagat Singh & others versus State of Haryana & others was filed before Hon'ble Punjab & Haryana High Court, Chandigarh by the petitioners praying therein to direct the respondents to grant them Selection Grade of Rs. 7500-12000 with effect from 01-01-1996 instead of 01-08-2000 as already granted to them vide Finance Department Haryana, Chandigarh Notification No. 1/19/98-4PR(FD) Dated 18-07-2001. The writ petition was disposed of by the Hon'ble High Court with direction to the respondents to decide the legal notices dated 01-06-2015 and 30-07-2015. The operative part of the order dated 19-09-2015 is re-produced as under:-

“Accordingly, at this stage, without commenting on the merits of the case as also on the issue of limitation which may arise in this case, the writ petition is disposed of with a direction to respondent No.2 to take a decision on the legal notices dated 01.06.2015 and 30.07.2015, Annexure P-6 and P-7 respectively, issued by the learned counsel for the petitioners, by passing a speaking order and after affording opportunity of hearing to the petitioners, preferably within four months from the date of receipt of a certified copy of this order. Needless to add that the decision so taken be communicated to the petitioners and if the decision is not to the satisfaction of the petitioners, they would be at liberty to challenge the same, in accordance with law.”

After due perusal of the legal notices, it has come into light that the pay scales of various categories of teaching staff on the School side in the Education Department have been provided under Sr. No. 6 of Part-I of the First Schedule. It has been observed that the pay scales for the posts of Head Teachers of Primary Schools, Head Masters of the Middle Schools, Lecturers in Senior Secondary Schools and Head Masters of High Schools do not find a mention along with other categories of teachers. As a result the revised pay scales of these categories were applicable as contained in Part-II of the First Schedule of the Haryana Civil Services (Revised Pay) Rules, 1998. The Government has, subsequently, further modified the pay scales of Head Teachers of the Primary Schools, Lecturers in Senior Secondary Schools and Head Masters of the High Schools vide its letters dated 7th August, 1998 and 26th September, 2000 respectively. The Lecturers (School Cadre) were granted Revised Pay Scale of Rs. 6500-10500 as time scale w.e.f. 01-01-1996 and 20% of cadre was granted Selection Grade of Rs.

7500-12000 w.e.f. 01-08-2000. The petitioners never challenged this notification and it became final with the passage of time. The petitioners have filed the present civil writ petition now for issuance of a writ in the nature of mandamus to direct the respondents to grant the selection grade of Rs. 7500-12000 with effect from 01-01-1996 instead of 01-08-2000 on the posts of lecturer(s) qua Head Masters which has been granted to them vide this department Order No. 6/52-2014 HRG-II (2) Dated 09-02-2015. The petitioners have also claimed the above benefits in view of the Govt. instructions issued vide order No. 62/26/2002-6GS I Dated 02-05-2002 without submitting any settled law in their favour in view of these instructions. The benefit granted to the other employees i.e. Headmasters is not feasible to petitioners on following grounds:-

1. The "Selection Grade" was granted to Lecturers including the petitioners with the object to provide incentive to those employees who have not been granted Assured Career Progression pay scales under Haryana Civil Services (ACP) Rules, 2008 or they have very limited outlets for promotion to higher posts. Accordingly, only 20% of the Lecturers were granted higher scale of pay.
2. That the claim of the petitioners is not covered under the Order No. 6/1/2001-1PR(FD) Dated 24-01-2001 issued by Finance Department Haryana, Chandigarh. It is further observed that the selection grade is intended to ensure that capable employees who may not get a chance of promotion on account of limited outlets of promotions should atleast be placed in the selection grade to prevent stagnation on the maximum of the scale. Selection grades are, therefore, created in the interest of greater efficiency, therefore, it is discretionary in nature.
3. That the Chief Secretary to Govt. Haryana, passed instructions vide Order No. 62/26/2002-6GS-I Dated 02-05-2002 to the Govt. Haryana, in view of CWP No. 4382 of 2002 (i.e. Satbir Singh & others versus State of Haryana & others) by Hon'ble Division Bench of Punjab & Haryana High Court at Chandigarh. In this case, the petitioners are claiming Selection Grade of Rs 7500-12000 w.e.f. 1-1-1996 instead of 1-8-2000 in terms of decision dated 1-12-2010 in CWP No 8082 of 2001 Sh. R.K. Verma & Others' judgment which is not feasible on following grounds:
 - (i) That in 2000, the petitioners were in Lecturer cadre whereas in CWP No. 8082 of 2001, the relief was granted to petitioners who were serving as Head Master cadre.
 - (ii) That the claim of the petitioner is altogether different than the law settled in R.K. Verma's case.

- (iii) That the instructions issued by Chief Secretary Haryana, Chandigarh vide Memo No. 62/26/2002-6GS-I Dated 02-05-2002 in which the judgment dated 21.03.2002 in CWP No. 4382 of 2002 titled as Satbir Singh & others versus State of Haryana & others by Hon'ble Division Bench of Punjab & Haryana High Court at Chandigarh is not applicable in the present case since the cadre of the petitioner (i.e. Lecturer cadre) is not identical to Headmaster cadre.

In view of the above, I am of the considered opinion that the legal notices have no merit and deserve to be rejected.

I pass order accordingly.
