In exercise of powers conferred under Rule 29 (3) read with Rule 3 of Haryana School Education Rules-2003 Education Department, Haryana hereby permit to add new proposed classes for higher stage. However, it is made clear that such permission will not enable such school to get recognition automatically for which the applicant shall have to fulfill the required conditions.

This letter of permission is based on the undertaking given by the applicant as per details given overleaf. Any violation of the undertaking automatically nullifies the permission. This permission is further subject to 'No Objection' from the 'Competent Authority' regulating the land use of the proposed site.

The permission to add new proposed classes for higher stage is only 'In-principle' approval of the Education Department to allow applicant to initiate steps and provide infrastructure to the new proposed classes of higher stage.

Students should not be admitted only on this permission without getting recognition. The recognition will be granted R.T.E. Rules-12 Appendix-II by the Department on fulfillment of prescribed norms as provided in Haryana School Education Rules-2003, in the interest of safety, health and welfare of students and other requirements.

* The managing committee shall abide by the provisions of Haryana School Education Rules 2003 (amended) & R.T.E. Ruels 2011 and amendments it any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provisions of the rules.

श्री लाल चन्द, लिपिक अब सेवानिवृत्त, रा0वरि0मा0वि0 भाखली (कुरुक्षेत्र) ने माननीय उच्च न्यायालय में सी0डब्ल्यू0पी0 नं0 23992/2015 दायर की। जिसमें निम्नानुसार मांग की गई:-

"The respondent to promote the petitioner on the post of Assistant from the post of Clerk as junior to the petitioner have been promoted on the post of Assistant and also to grant 1st, 2nd and 3rd ACP Scales to the petitioner and all other service benefits i.e. LTC, full back wages and salary for the period petitioner remained out of the service till his reinstatement vide order dated 03.12.2012 (Annexure P-2) in view of the office order dated 17.10.2014 (Annexure P-9) passed by the respondent No.2.

उपरोक्त याचिका को माननीय उच्च न्यायालय द्वारा दिनांक 16.11.2015 को डिस्पॉज ऑफ कर दिया। माननीय उच्च न्यायालय द्वारा निम्नानुसार आदेश दिए गए:-

"The petitioner states that he ought to be given the entire service benefits on reinstatement particularly when the period he remained away from service has been treated as period on duty. It is suggested in the petition that a representation dated 07.01.2015 was made in this regard but the same is not a part of the petition. Therefore, the court would not lend any credence to such an assertion. The petition is disposed of with liberty to the petitioner to make a comprehensive representation to the respondents with regard to the benefits that he intends to claim within a period of four weeks from today, whereupon the respondents will consider the same and take a decision thereon within a period of two months thereafter."

उपरोक्त कर्मचारी द्वारा दायर की गई याचिका एवं माननीय न्यायालय के आदेशों का अवलोकन करने उपरान्त विभाग के संज्ञान में आया कि श्री लाल चन्द, लिपिक को निदेशालय क्रमांक 5/155-1994 एम0ई0 दिनांक 26.02.1996 तथा निदेशालय के आदेश क्रमांक सम दिनांक 23.04.1999 को नियम-7 के तहत चार्जशीट जारी की गई थी। जिसमें पहली चार्जशीट में कर्मचारी पर लगातार लम्बी अवधि तक बिना सूचना के विद्यालय से अनुपस्थित रहने का आरोप था। जिसमें श्री एम0एल0 कालरा, जिला शिक्षा अधिकारी, कुरुक्षेत्र को जांच अधिकारी नियुक्त किया गया। जिसमें जांच अधिकारी द्वारा कर्मचारी पर लगाए गए सभी आरोपों का सिद्ध बताया गया। जांच रिपोर्ट की प्रति कर्मचारी को भेजी गई, जिसका कोई उत्तर या प्रतिवेदन निदेशालय में प्राप्त नहीं हुआ। इसके बाद कर्मचारी द्वारा सी0डब्ल्यू0पी0 नं0 1792/2010 दायर की गई, जिसका फैसला दिनांक को हुआ। जिसको मद्देनजर रखते हुए निदेशालय के आदेश क्रमांक 5/155-1994 एम0ई0 दिनांक 05.03.2013 के तहत कर्मचारी को सेवा से बर्खास्त करने का शोर्कोज नोटिस दिया गया। जिसका उत्तर कर्मचारी द्वारा दिनांक 14.05.2013 को निदेशालय में दिया, जिसमें कर्मचारी का निजी सुनवाई का अवसर दिनांक 03.07.2013 के लिए दिया गया।

जिसमें कर्मचारी द्वारा कोई नया तथ्य प्रस्तुत न करने के कारण सक्षम अधिकारी द्वारा उसकी घरेलू परिस्थितियों को देखते हुए मामले में सहानुभूतिपूर्वक विचार करते हुए कर्मचारी की एक वार्षिक वेतनवृद्धि संचित प्रभाव से रोकने के आदेश पारित किए गए।

उपरोक्त के अलावा दूसरी चार्जशीट में कर्मचारी पर गबन करने, अधिकारियों के आदेश न मानने, बिना सूचना के अनुपस्थित रहने, कार्य करते समय अपनी मर्जी से रिकार्ड के साथ कांट-छांट करके खुद को एवं पैसा लेकर दूसरे स्टॉफ सदस्यों को अनावश्यक तौर पर दूसरों स्टॉफ सदस्यों को लाभ पहुंचाते हुए सरकारी खजाने का फ्रॉड करने के आरोप लगाए गए थे। उक्त चार्जशीट का उत्तर कर्मचारी द्वारा निदेशालय में प्रस्तुत किया गया, जिससे सन्तुष्ट न होकर सक्षम अधिकारी द्वारा श्रीमती सन्तोष राणा, जिला शिक्षा अधिकारी, पानीपत को जांच अधिकारी नियुक्त किया गया। जिसमें जांच अधिकारी द्वारा लगाए गए आरोप सिद्ध पाए गए। जिसमें कर्मचारी द्वारा गबन की गई राशि 3450/-—रु0 व 7750/-—रु0 जमा करवा दी गई और अपनी घरेलू परिस्थितियां ठीक न होने का हवाला दिया गया तथा सेवानिवृत्ति तिथि व्यतीत होने बारे अनुरोध किया गया। क्योंकि कर्मचारी दिनांक 31.07.2014 को सेवानिवृत्त हो चुका है। इसको मद्देनजर रखते हुए तथा कर्मचारी की घरेलू परिस्थितियों को मद्देनजर रखते हुए कर्मचारी के विरुद्ध जारी की गई चार्जशीट में सक्षम अधिकारी द्वारा नरम रूख अपनाते हुए कर्मचारी की दो वेतन वृद्धियां रोकने के आदेश पारित किए गए तथा कर्मचारी के निलम्बन काल को ड्यूटी पीरियड मान लिया गया। जब कर्मचारी के निलम्ब अवधि के पीरियड पर फैसला लिया गया, उस समय कर्मचारी का निजी रिकार्ड निदेशालय स्तर पर उपलब्ध नहीं था। क्योंकि कर्मचारी द्वारा अपनी सेवा क्षेत्रीय कार्यालयों में दी गई थी, इस कारण से कर्मचारी का निजी रिकार्ड भी क्षेत्रीय कार्यालयों में ही होता है। जब उक्त कर्मचारी के रिकार्ड बारे रिपोर्ट जिला शिक्षा अधिकारी, कुरुक्षेत्र से मांगी गई तो कर्मचारी द्वारा मिली भगत करके उक्त रिपोर्ट भेजी गई। जब कर्मचारी द्वारा माननीय न्यायालय में याचिका दायर की गई तथा माननीय न्यायालय के फैसले दिनांक 16.11.2015 के मद्देनजर कर्मचारी को अपना विस्तृत प्रतिवेदन 4 सप्ताह में देना था, जोकि नहीं दिया गया। फिर भी कर्मचारी को निजी सुनवाई का अवसर प्रदान किया गया। लेकिन कर्मचारी द्वारा दिनांक 19.02.2016 व 09.03.2016 को निजी सुनवाई हेतु निदेशालय में उपस्थित नहीं हुआ। इसके बाद कर्मचारी जहां कार्यरत था, उक्त विद्यालय के प्राचार्य को दूरभाष पर सन्देश देते हुए निर्देश दिए गए कि वह उक्त कर्मचारी को निजी स्तर पर सूचित करें जिसके सन्दर्भ में प्राचार्य द्वारा उनके निजी दूरभाष पर भी निदेशालय में उपस्थित होने बारे सूचना दे दी गई। लेकिन उसके बावजूद भी कर्मचारी सक्षम अधिकारी के समक्ष निदेशालय में उपस्थित न होकर अपना प्रार्थना पत्र माननीय न्यायालय के आदेशों के काफी समय बीत जाने के बाद प्राचार्य को दिया। जिसको विचारोपरान्त निदेशालय स्तर से प्राचार्य, रा0वरि0मा0वि0 भाखली (कुरुक्षेत्र) से कर्मचारी का निजी रिकार्ड मूल रूप से निदेशालय में मंगवाया गया। जिसका अध्ययन करने से पता चला कि कर्मचारी की नियुक्ति तिथि दिनांक 16.03.1981 के बाद लगातार सम्बंधित मुखिया द्वारा जो-जो वार्षिक गोपनीय रिपोर्ट लिखी गई, वह मुख्य तौर पर एवरेज



या उससे भी नीचले स्तर की लिखी गई हैं। कर्मचारी का पूर्ण रिकार्ड में से केवल वर्ष 2013-14 व 2014-15 जोकि केवल डी0डी0ओ0 द्वारा ही अच्छे वर्ग की दिखाई गई है। जिस पर द्वितीय अपीलिय अधिकारी के हस्ताक्षर भी नहीं है, ठीक दिखाई गई हैं। अन्य पूर्ण रिकार्ड पर सम्बंधित मुखिया द्वारा कर्मचारी की सेवा सन्देहजनक बताई गई है। क्योंकि हरियाणा सरकार की नीति अनुसार यदि कर्मचारी का पिछले 10 वर्षों का सेवारिकार्ड जैसे वार्षिक गोपनीय रिपोर्ट तथा सम्बंधित अधिकारी द्वारा कर्मचारी की पिछले वर्षों की सेवा को प्रमाणित किया गया हो। तो उसी आधार पर कर्मचारी को सेवा विस्तार या उच्च वेतनमान/ऐ0सी0पी0 का लाभ प्रदान किया जा सकता है। लेकिन उक्त कर्मचारी का सेवा रिकार्ड पिछले दो वर्षों जैसे वर्ष 2013-14 व 2014-15 (ACR upto July 2014 as retired on 31.07.2014) को छोड़कर सभी वर्षों का सन्देहजनक रहा है। जिसको मददेनजर रखने उपरान्त कर्मचारी किसी भी प्रकार के वित्तीय लाभ जैसे पदोन्नति/ऐ0सी0पी0/एल0टी0सी0 इत्यादि का पात्र नहीं बनता।

अतः उपरोक्त अंकित स्थिति को मददेनजर रखते हुए, क्योंकि कर्मचारी के मामले में पहले ही सक्षम अधिकारी द्वारा नरम रूख अपनाकर कर्मचारी को सेवा से बर्खास्त नहीं किया गया है। इसलिए मैं मामले में सक्षम अधिकारी होने के नाते, श्री लाल चन्द, लिपिक अब सेवानिवृत्त, रा0वरि0मा0वि0 भाखली (कुरुक्षेत्र) को माननीय न्यायालय के माध्यम से मांगे गए लाभ जैसे पदोन्नति/ऐ0सी0पी0/एल0टी0सी0 को कर्मचारी का सेवारिकार्ड सन्देहजनक होने के कारण न देने के आदेश पारित करता हूँ।

In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth or any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student for elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amnedments it any thereafter. The Managing shall be liable for diciplinary action in case of violation of any provision of the rules.
