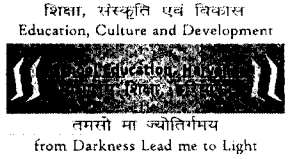

**Terms and conditions:-**

1. The benefit of ante-date appointment w.e.f. 14.12.2013 will be admissible to him only for notional pay fixation and seniority and actual financial benefits will be admissible to him from the date he joins duty as PGT Punjabi.
