He submitted reply to the said charge sheet on 16.02.2016. After careful consideration of the reply and relevant record it has been found that the reply was not satisfactory. Therefore, opportunity of personal hearing was also afforded to him on 22-3-2016. After hearing him in person, I am of considered view that he is fully responsible for the lapse as alleged. Therefore, taking an overall view of the matter, I order to stop his one annual increment without cumulative effect.

OFFICE OF DIRECTOR SECONDARY EDUCATION, HARYANA PANCHKULA**ORDER****No. 6/80-2016 PS (2)****Dated, Panchkula, the 02.05.2016**

This order of mine shall dispose of a complaint dated 22.04.2016 against The Shri Ram School, DLF Ph- 3, Gurgaon which was filed by the members of committee constituted by Secretary (SCPCR)-cum-Director, Women and Child Development Department, Haryana, Panchkula.

The brief fact of the complaint are that the committee visited the said school on 22.04.2016 at 11.20 A.M. in compliance of direction of Hon'ble High Court passed in CWP No. 6907 of 2009, 4962 of 2013 and COCP No. 1834 of 2015 titled Court on its own motion V/s State of Punjab and others whereby the teams were to be constituted for Safe School Vehicle Policy. During the inspection, the committee member were asked to sit in conference hall and were informed that Smt. Girija is the representative for school for Safe School Vehicle Policy. Thereafter, she left the conference hall and came back with 3-4 female members and ordered the committee members to show their identity cards in a very indecent tone. Although, Sh. B.K. Goyal, Member of SCPCR, Haryana, responded very politely with the female members of the school but the female members of the school continued misbehaving to the level that the team was forced to leave the premises of the school. Further, the staff members and female members of the school started video recording and taking picture of the committee which is very shameful act by the school staff members. Such act of the school staff members is clearly the contempt of Court directions by obstructing the Government Officials to comply with Court orders.

The action of the school management as explained above was viewed seriously and a show cause notice under Rule 43(1) of the Haryana School Education Rules, 2003, amended in 2007 was issued on 31.03.2015 to the school management as to why the recognition/NOC granted to their school may not be withdrawn from the next academic session 2016-17. Rule 43 of the rules is reproduced as under:-

“43(1) The appropriate authority may withdraw/suspend the recognition/NOC of a school after giving reasonable opportunity against the proposed action to be taken against the school in the following circumstances:-


(a) x x x x x x x x x x

(b) If a school is found involved in malpractices such as mass copying in public examination conducted by any Board or bogus enrolment tempering of records or non co-operation to appropriate authority its recognition shall be withdrawn without any notice and the concerned Board shall be intimated (be asked to withdraw its affiliation);

(c) If the managing committee of the school obtains recognition/NOC by fraud, mis-representing or suppressing any particulars or after obtaining recognition/NOC fails to continue to comply with any of the conditions specified in these rules the appropriate authority after giving a reasonable opportunity and one month notice to show cause against proposed action can withdraw recognition/NOC.”

Therefore, under the aforesaid Rule, the school management i.e. the trust is being issued a notice of showing cause as to why the NOC granted to The Shri Ram School, DLF Ph- 3, Gurgaon may not be withdrawn from the next academic session 2016-17. The reply/representation, if any, the management wants to submit, should reach in the department within a period of 15 days, failing which, it will

be presumed that the management/trust has nothing to say in this regard and the appropriate order shall be passed in accordance with Rules.


