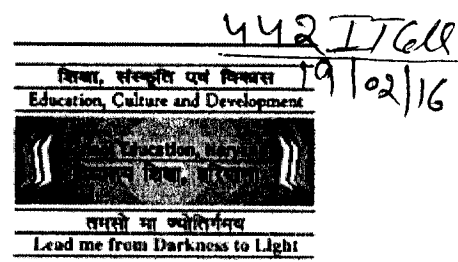

- 2 No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- 3 No male teacher below the age of 50 years be allowed to join in the girls schools.
- 4 If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ. If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- 5 In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- 6 In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.



Whereas, a penalty of stoppage of three grade increment with cumulative effect was inflicted upon Sh. Satpal, Lecturer in Hindi, GSSS Kathe Majra vide order No. 16/05-2008 HRL(5) dated 24.09.2013. Against the aforesaid orders, Sh. Satpal, Lecturer in Hindi has preferred a memorial dated 08.11.2013 before His Excellency, the Governor of Haryana.

After taking cognizance of his memorial Governor of Haryana has observed as under:-

“The memorial dated 08.11.2013 preferred by Sh. Satpal, Lecturer in Hindi, GSSS Kathe Majra, Ambala against Government order No. 16/05-2008 HRL (5) dated 24.09.2013 vide which punishment of penalty of stoppage of three increment with cumulative effect was inflicted upon him has been considered.

I have gone through all the facts and record of the case. I have also heard the memorialist in person on 23.12.2015. During personal hearing, the memorialist submitted that the Inquiry Officer has categorically observed that on 11.11.2007 it was Sunday and the school was closed being holiday. In such a situation the allegation of non-acceptance of application does not arise. Since in all six applications were received and that too from different blocks, it could not have been possible without proper publicity. As per Government's instructions, the requirement is that the vacancy should be put on the notice board. As regards workload for the post of Drawing Teacher, the requisite approval was granted by the D.E.O. with the approval of the Director. Hence, it cannot be said that there was no workload for the post. The Publishing Authority while giving dissent has not amply justified the view taken by him/her.

In view of the above and agreeing with the version of the Inquiry Officer, I accept the memorial of the applicant and set aside the impugned order dated 24.09.2013 issued by Principal Secretary to Government, School Education Department, Haryana.”

The same is communicated accordingly.

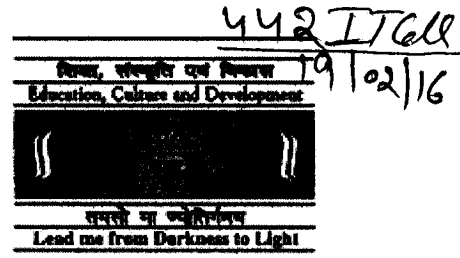
