





This all happened because of the wrong data forwarded to HQ by the school concerned. Accordingly, to set right this wrong the post of PGT (Political Science) be treated as not abolished and duly allocated in GSSS Nangal Sirohi (Mahendergarh) [3886].

Smt. Raj Bala had not completed her tenure of 5 years in her present zone of posting nor she wanted to be transferred from her present place of posting i.e. GSSS Nangal Sirohi be immediately re-joined against the post of PGT (Political Science) and her on-road period / compulsory waiting period with effect from her relieving from that school till re-joining be treated as duty period.


