ORDER NO. 13/202-2015 HRME (4) DATED, PANCHKULA, THE 2/1/16

Whereas the petitioners filed a CWP No. 23322 of 2015, titled as Chaman Lal and others Vs. State of Haryana and another in the Hon'ble Punjab & Haryana High Court to direct the respondent to assign the current duty charge on the post of Superintendent to the petitioners from the date, it has been assigned to the juniors of the petitioners. The above said writ petition was disposed of by the Hon'ble High Court on 02.11.2015, the operative part of the order is reproduced here as under:-

"However, since the petitioners have made a representation to the respondents, the instant writ petition is disposed of with a direction to the respondents to consider the claim of the petitioners as prayed for in this petition.

The impediment in the way of the court to exercise its jurisdiction under Article 226 of the Constitution of India would not be construed to be any comments on the merits of the claim of the petitioners which shall be considered independently de hors the observations made regarding enforcement of a right through a writ court within a period of two months from the date of receipt of certified copy of this order."

In compliance of the aforesaid order of the Hon'ble Court, the representation of the petitioner dated 07.04.2015 was examined by the office of respondent and it has been found that the petitioners belong to the Schedule Caste category and were appointed as clerk in 1984. Subsequently, they were promoted as Assistant in 2003. Further, they were promoted as Dy. Superintendent in 2011. In this regard, it is submitted that both the promotions given by the Department to the petitioners were in view of the giving benefit of accelerated seniority of 20 % reservation of scheduled caste category in the Class III posts. But, now the petitioners are claiming to grant


the benefit of current duty charge to the post of Superintendent and the post of superintendent is Class II. However, the employees who have been given the current duty charge as Superintendent vide order dated 11.08.2014 are seniors to the petitioners as clerk as they were appointed as clerk in the year 1975 and the category of superintendent is Class II and there is no provision of reservation in promotion to Class II category.

The Chief Secretary Haryana vide letter dated 09.02.1975, clearly specified that there will be no reservation in Class I and Class II posts, therefore, the reservation policy is not applicable on the Class II posts.

As there is no provision of reservation in promotion/current duty charge to the post of Class-II, thus, the petitioners are not entitled for granting Current Duty Charge/promotion to the post of Superintendent.

After going through the relevant provisions of the Rules/instructions and record of the petitioners, it has been found that the claim of the petitioners is not tenable and liable to be rejected.

I, order accordingly.

Whereas, Sh. Karam Pal, Principal, Govt. Sr. Sec. School, Dhansu (Hisar) was charge sheeted under Rule-8 of Punishment & Appeals rules, 1987 vide order No. 5/247-2013 HRG-I (1) Dated, 10.02.2014, wherein following charges were levelled against him:-

" यह कि दिनांक 12.11.2013 को सांय 4.10 बजे सुन्दर सिंह वर्सिस श्री कर्मपाल, प्राचार्य, राठवाडा(3) मोडाखेडा के केस में आरटीआई की अपील जिला शिक्षा अधिकारी, हिसार के समक्ष सुनी जा रही थी। सुनवाई के दौरान उसने गुस्से में आकर जिला शिक्षा अधिकारी, हिसार से गाली गलौच किया। इसके अतिरिक्त अपील में उपस्थित एसपीआईओ कम उप जिला शिक्षा अधिकारी, हिसार श्रीमती संतोष हुडडा से बदतमीजी से अनाप सनाप बोला तथा उसके साथ अमद्र व्यवहार किया। ऐसा करके प्राचार्य ने विभागीय नियमों की अवहेलना की है तथा सरकारी कार्य में बाधा पहुंचाई है। मौके पर आरटीआई डिलिंग श्री कमल, लिपिक आरटीआई मांगने वाला श्री सुन्दर सिंह बगला, श्रीमती मीना रहेजा, खण्ड शिक्षा अधिकारी, आदमपुर भी उपस्थित थी।"

He replied to the above charge sheet on 10.02.2014 and denied all the charges levelled against him. Thereafter, comments from the DEO, Hisar were sought and DEO vide letter dated 24.09.2014 had informed that both Sh. Karam Pal, Principal and the then Dy. DEO Smt. Santosh Hooda were responsible for causing disturbance in the school. Sh. Karam Pal was granted personal hearing on 14.07.2015 and during personal hearing he mainly contended that the service record of the petitioner is quite satisfactory and his result for the year 2014-15 is above the board result and GSSS, Moda Khera (Hisar) where the applicant is working as Principal has been declared first in the Block under CM Sondriyakaran Scheme. He also assured to remain careful in future.

Keeping in view the facts of the case, reply of the applicant and contentions raised by him during personal hearing in support of his defence, applicant deserve some lenient view. Thus, by taking a lenient view, I pass an order to file the charge sheet served upon Sh. Karam Pal, Principal, Govt. Sr. Sec. School, Dhansu (Hisar) vide order dated 10.02.2014.

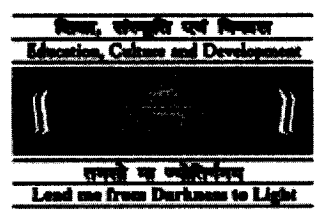
