It was further required on his part to check and verify all the facts before selecting the candidate, but he miserably failed to do so and appointed the candidate who did not have subject combination at the time of her engagement as per the requirement of the rules. It clearly shows that there is gross negligency on part of Sh. Arun Kumar.

Keeping in view the facts stated above that Sh. Arun Kumar has caused financial loss to the Government by appointing ineligible person, thus, I ordered to impose a penalty of Rs. 10,000/- from his own pocket and deposited in the Haryana Govt. Treasury through challan.
