Vide order No. 2/140-2016-PGT-II(1) dated 06.08.2016 Sh. Lalit Rupesh was transferred from GSSS Jhajjar [3099] to GSSS Jahangirpur (Jhajjar) [3161] whereas in his place Smt. Jyoti PGT Physics [203176] was transferred from GGSSS Bidhal (Sonipat) [3446]. But prior to this, Sh. Lalit Rupesh had got a stay order to remain in this school. It is important to note that these stay orders were issued in CWP No. 9575 of 2016 wherein the petitioner Sh. Lalit Rupesh contended that his transfer orders dated 01.04.2016 were based on the wrong facts of zero strength of students of Physics in 11th and 12th classes. But it is also a fact that Sh. Lalit Rupesh has completed nearly 18 years of service in zone 1. So as per New Transfer Policy, 2016 he was liable to be transferred. Accordingly his transfer orders were duly made on 06.08.2016, but he was not relieved from the school due to stay orders in the CWP No. 9575 of 2016. Now the Hon'ble Court has dismissed the CWP hence the stay orders are also automatically vacated.

Therefore, Sh. Lalit Rupesh PGT Physics [036885] be relieved from GSSS Jhajjar [3099] immediately and Smt. Jyoti PGT Physics [203176], who is on-road due to her displacement, be allowed to join at GSSS Jhajjar [3099]. The on-road period of Smt. Jyoti be treated as duty period for all practical purposes. Compliance report be submitted to the Head Quarter today only.
