

**ORDER No. 5/47-2014 HRG-II (2) Dated, Chandigarh, the 12.08.2016**

Whereas, an FIR No. 65 dated 03.05.2003 u/s 325 IPC was registered in PS, Kalanaur (Rohtak) against Sh. Rajender Sethi, Head Master GHS Pilana (Rohtak). The case was decided on 03.03.2014 and 07.03.2014 by Sh. Ashwani Kumar, CJM, Rohtak and Sh. Rajender Sethi, Head Master, GHS Pilana was convicted and sentenced him to undergo rigorous imprisonment for a period of 1 year alongwith a fine of Rs. 5000/- for commission of offence punishable u/s 325 IPC. He was placed under suspension vide office order dated 16.02.2015/02.03.2015. Thereafter, an appeal was filed by Sh. Rajender Sethi in the Court of Hon'ble Additional District and Session Judge and his appeal was accepted on 27.03.2015 and modified the order dated 03.03.2014 to the extent that instead of undergoing actual sentence, the appellant is to be released on probation on good conduct on his furnishing probation bond in the sum of Rs. 30000/- with one surety in the like amount to the satisfaction of this Court for a period of 2 years and further directed to give compensation an amount of Rs. 25,000/- to the complainant i.e. Sh. Hans Raj as compensation. Later on he was reinstated.

Further, Sh. Rajender Sethi, Headmaster has challenged the judgment of conviction dated 03.03.2014 and order of sentence dated 07.03.2014 by filing CRR No. 1584 of 2015 in Hon'ble Punjab and Haryana High Court. The matter was listed for hearing on 24.02.2016 and Hon'ble High Court has passed the following order:-

This case stands allowed by giving benefit of doubt to the accused petitioner Rajender Sethi, he is acquitted of the charges frame against him. The judgment passed by the Courts below are not as per evidence of record and amount of misreading of evidence qua conviction of Rajender Sethi.

As accused Rajender Sethi has been acquitted of the charges, therefore, CRR No. 2240 of 2015 filed by Hansraj against the order of releasing of Rajender Sethi on probation, has become infructuous and the same is dismissed.

As accused petitioner Rajender Sethi is on probation, his probation bonds stand discharged.

In the light of above facts and judgement of Hon'ble High Court, the said incumbent is entitled for full pay and allowances for the suspension period from 07.03.2014 till 11.08.2015, as provided in sub Rule 2 of Rule 7.3 of CSR Volume-I, Part-I and also the said suspension period is required to be treated as a period spent on duty for all other purposes, as per sub Rule 4 of Rule 7.3 of the said rules. However, no departmental proceedings under Rule 7 or 8 of Haryana Civil Services (Punishment and Appeal) Rules 1987, in the matter have been pending against the said incumbent.

I pass order accordingly.
