


श्री सुरेन्द्र कौशिक, उप-अधीक्षक (अधीक्षक सी0डी0सी0), कार्यालय जिला शिक्षा अधिकारी, हिसार को निदेशालय के यादी क्रमांक 5/8-2016 एच0आर0एम0ई0 (2)/2923 दिनांक 29.01.2016 को हरियाणा सिविल सेवा (दण्ड एवम अपील) नियम- 1987 के नियम-8 के तहत चार्जशीट किया गया था। कर्मचारी को निम्न आरोपो में आरोपित किया गया :-

1. यह कि जांच क्रमांक 1 आफ 2006 विरुद्ध श्री पुष्करमल वर्मा नारनौल में दोषी पाए गये उप-जिला शिक्षा अधिकारियों/उप-मण्डल शिक्षा अधिकारियों/ प्राचार्यों/मुख्यअध्यापको/ डी0डी0ओ0 जो सेवा में कार्यरत थें के विरुद्ध हरियाणा सिविल सेवा (दण्ड एवं अपील) नियम 1987 के नियम-7 के अन्तर्गत एवं सेवा निवृत्त हो चुके अधिकारियों के विरुद्ध सी0एस0आर0 के नियम 2.2 बी के अन्तर्गत अनुशासनिक कार्यवाही की जानी थी। वर्ष 2008 में रिपोर्ट प्राप्त होते ही समय समय पर जिला हिसार से सम्बंधित दोषी अधिकारियों का विवरण मांगा गया। परन्तु उनके द्वारा विवरण उपलब्ध नहीं करवाया गया। अन्तत् उपलब्ध रिकार्ड के आधार पर दोषी अधिकारियों के विरुद्ध नियम-7 के अन्तर्गत चार्जशीट का प्रारूप एल0आर0 हरियाणा को वैटिंग हेतु भेजा गया था। एल0आर0 हरियाणा ने उनके यादी क्रमांक 818-सी0(19)डी0ए0/एच0/2014/628 दिनांक 21.02.2014 द्वारा यह कहते हुए मामला लौटा दिया कि चार्जशीट में की गई नियुक्तियों तथा उनकी तिथियों इत्यादि का विवरण भी अंकित किया जाए। जिला हिसार से सम्बंधित दोषी कर्मचारियों द्वारा की गई नियुक्तियों तथा उनकी तिथियों का विवरण बार-बार मांगा गया। इस सम्बंध में अनेक बार पत्र लिखें गये, समय समय पर अ0स0 पत्र भी लिखें गये तथा कई बार दुरभाष पर भी सदंश दिये गये, परन्तु उसने सम्बंधित सूचना निदेशालय को नहीं भिजवाई जिसके कारण उक्त अधिकारियों को चार्जशीट नहीं किया जा सका, जबकि विधान सभा आश्वासन कमेटी को शिक्षा मंत्री महोदय द्वारा शीघ्र कार्यवाही करने का आश्वासन दिया हुआ था।

कर्मचारी द्वारा दिनांक 17.02.2016 को चार्जशीट के जवाब तथा दिनांक 07.12.2016 को दिए गए प्रतिवेदन पर माननीय निदेशक सैकण्डरी शिक्षा महोदय द्वारा कर्मचारी को दिनांक 07.12.2016 को निजी सुनवाई का मौका दिया गया। निजी सुनवाई के दौरान उस द्वारा अपनी स्थिति स्पष्ट की गई। कर्मचारी को सुनने उपरान्त उसे **Recorded warning** की सजा देता हूं। जिसकी एक प्रति उसकी निजी मिसल में भी लगाए जाए।
