

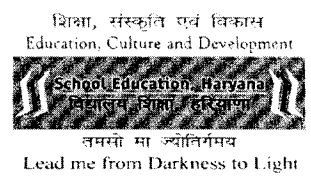

श्री राजबीर सिंह, लिपिक अब मृतक कार्यालय रा0उ0वि0 बिहोली जिला पानीपत को निदेशालय के आदेश क्रमांक 5/88-97 एच0आर0एम0ई0 (5) दिनांक 01.10.97 द्वारा नियम 7 के तहत चार्जशीट किया गया था, जिसमें उस पर निम्न अनुसार आरोप लगाए गए थे :-

1- यह है कि श्री राजबीर सिंह लिपिक ने 12.7.96 को श्री रणधीर सिंह एस0एस0 मास्टर, रा0उ0वि0 बिहोली के भविष्य खाता नं0 50695 में गलत तौर से 1,40,000/-रु0 की राशि निकलवाई ।

कर्मचारी द्वारा चार्जशीट का उत्तर दिया जिसमें उसने लगाया गया आरोप निराधार बताया । कर्मचारी के उत्तर को जिसको सन्तोषजनक नहीं पाया गया, तत्पश्चात निदेशालय के आदेश दिनांक 23.07.2015 द्वारा श्री औमप्रकाश सेवा निवृत्त सेशन जज को जांच अधिकारी लगाया गया। जांच अधिकारी ने दिनांक 16.12.15 को अपनी जांच रिपोर्ट विभाग को सौंपी जिसमें कर्मचारी पर लगाए गए आरोप सिद्ध नहीं पाए गए ।

यहां यह भी अंकित है कि कर्मचारी को दिनांक 31.3.98 को निलम्बित किया गया तथा दिनांक 06.04.2000 को लम्बित जांच बहाल किया गया । जांच अधिकारी द्वारा दी गई जांच रिपोर्ट से सहमति प्रकट करते हुए तथा रिकार्ड का अवलोकन करने उपरान्त मैं, सक्षम अधिकारी होने के नाते तथा मृतक कर्मचारी के मामले में सहानुभूतिपूर्वक विचार करते हुए इस निष्कर्ष पर पहुंचा कि कर्मचारी के निलम्बन काल 31.3.98 से 06.04.2000 तक को Leave of kind due तथा मृतक कर्मचारी की नियम-7 की चार्जशीट को फाईल करने के आदेश पारित करता हूं ।
