3. यह कि श्री सत्यवान सिंह, लिपिक वर्ष 2005 में 15 दिन, वर्ष 2006 में 16 दिन, वर्ष 2007 में 62 दिन, वर्ष 2008 में 23 दिन, वर्ष 2010 में 62 दिन, वर्ष 2011 में 98 दिन, वर्ष 2012 में 11 दिन तथा वर्ष 2012 में ही 03.12.2012 से 06.12.2012 तक विद्यालय से बिना सूचना के अनुपस्थित रहा तथा इसके बाद भी कर्मचारी के आचरण एवं उपस्थिति बारे कोई रिपोर्ट विभाग में उपलब्ध नहीं है।”

“Charge No. 1:- Sh, Satyawan CO cannot be termed as habitual of remining absent from the school without information in view of his leaved sanctioned by the headmaster except for the period 03.12.2012 to 06.12.2012. This charge is not proved.

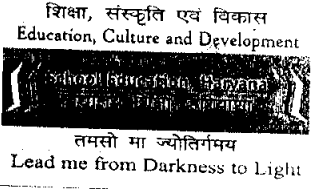


