

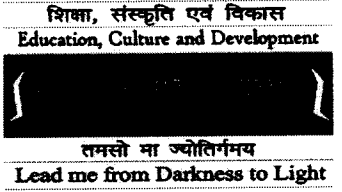

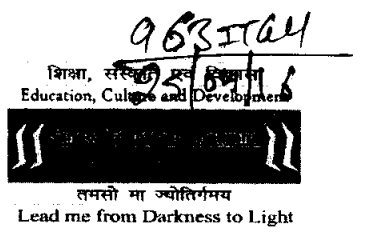

Whereas Sh. Balbir Singh, Class-IV O/o GHS Kaliaana (Bhiwani) is a General Category candidate. On receipt of CWP No. 4391 of 2015 titled Balbir Singh Vs. State of Haryana, his case was examined. As per the condition of the promotions from Class-IV to the Post of Clerk, it was specifically mentioned that the candidate of General Category who have passed Matric, as qualification and appointed on regular basis upto 31.12.1995 and Schedule Caste category official appointed upto 31-12-1998, are eligible for promotions. As per record, available in IT Cell of this Department, his seniority was to be counted w.e.f. 11.07.1997 as he was transferred from GPS Kakroli Hathi (Bhiwani) to GHS Kaliaana (Bhiwani) vide order No. E-III-97/2010-17 dated nil. The detail of his service record is as under:-

1. Date of appointment as a Class-IV on regular basis - 19.04.1994


