श्री सतीश कुमार गुप्ता, वरिष्ठ प्राध्यापक (सेवानिवृत्त), डाईट पलवल (कुरुक्षेत्र) के विरुद्ध निदेशालय के आदेश क्रमांक 5/143-2013 एच.आर.जी.-1 (1) दिनांक 05.03.2014 के तहत हरियाणा सिविल सेवा नियम (दण्ड एवं अपील) नियम 1987 के नियम-8 के अन्तर्गत चार्जशीट जारी करते हुए निम्न आरोप लगाए गए थे:-

1. यह कि उसने दिनांक 06.09.2013 को जांच के समय जिला शिक्षा अधिकारी, कुरुक्षेत्र से दुर्व्यवहार किया व निदेशक, एस0सी0ई0आर0टी0 के आदेशों की भी अवहेलना की तथा एस0सी0ई0आर0टी0 द्वारा जारी आदेशों बारे स्टाफ को अवगत नहीं करवाया।
2. यह कि उसने संस्थान में 7 लिपिकों के कार्यरत होने पर भी किसी भी विंग ईन्चार्ज को कोई क्लर्क नहीं दिया।
3. यह कि उसने कार्य का न्यायपूर्ण बंटवारा करने की बजाये No Work No Pay का आदेश निकालकर महिला प्राध्यापिका को मानसिक रूप से प्रताड़ित किया।
4. यह कि उसने महिला प्राध्यापिकाओं के साथ दुर्व्यवहार किया।
5. यह कि उसका पुरुष प्राध्यापकों के बारे में रवैया पक्षपातपूर्ण होना।
6. यह कि उसने श्रीमती नीरजा शर्मा का पुनर्नियुक्ति का प्रस्ताव निदेशालय को नहीं भेजा।
7. यह कि किसी भी वरिष्ठ प्राध्यापिका को एस0ई0पी0 मोनिटरिंग के लिए नहीं भेजा।
8. यह कि डी0डी0 पावर का दुरुपयोग करना जैसे बार-2 प्राध्यापिकाओं के खिलाफ आदेश पुस्तिका का प्रयोग करना व स्पष्टीकरण मांगना तथा छोटी-2 बात के लिए निदेशक महोदय को तबादले तक की सिफारिश कर देना।

उपरोक्त चार्जशीट का उत्तर श्री सतीश कुमार गुप्ता द्वारा दिनांक 06.05.2014 को निदेशालय में प्राप्त हुआ, जिसमें उन्होंने बताया कि जांच अधिकारी द्वारा पूर्ण तथ्य विभाग को नहीं बताए गये हैं तथा अपने ऊपर लगाए गये आरोपों को निराधार बताया और अब वह सेवा से सेवानिवृत्त भी हो चुका है इसलिए उसके विरुद्ध चार्जशीट को सरकार की हिदायतों अनुसार ड्राप किया जाये। श्री सतीश कुमार का यह कहना ठीक है कि सरकार की हिदायतों दिनांक 22.08.1975 अनुसार माईनर पेनल्टी में की गई चार्जशीट को सेवानिवृत्ति के बाद जारी रखने का कोई प्रावधान नहीं है।

उपरोक्त तथ्यों के मध्यनजर तथा सरकार की हिदायतों को ध्यान में रखते हुए मैं सक्षम अधिकारी होने के नाते इस निष्कर्ष पर पहुंचा हूं कि श्री सतीश कुमार गुप्ता, वरिष्ठ प्राध्यापक (सेवानिवृत्त), डाईट पलवल (कुरुक्षेत्र) के विरुद्ध नियम-8 के तहत जारी की गई चार्जशीट को ड्राप करना उचित होगा। अतः मैं चार्जशीट को ड्राप करने के आदेश पारित करता हूं।

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the Appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.


