ORDER

Memo No. 36/1-2014 PS (3)

This order of mine shall dispose of an appeal filed by Sh. Sant Lal, Principal, Nav Jyoti Sr. Sec. School, Birohar (Jhajjar) authorised by Nav Jyoti Shiksha Samiti (Jhajjar), against the order dated 25.07.2015 and 01.04.2016 passed by the Director Secondary Education, Haryana whereby the permanent recognition of the appellant's school was withdrawn w.e.f. the academic session 2016-17.

At the outset, the brief facts of the case are that a complaint was received against Nav Jyoti Shiksha Samiti, Birohar (Jhajjar) that it has got permanent recognition of the school on the basis of false documents regarding the school premises in which residential building is existing and the distance of playground from the school building is not as per norms. In addition to this, the school building of 9th to 12th classes is also at a distance of about 2 K.M. from the Middle school building. The land where the Middle school is established is also not as per Rules/norms. The complainant had requested to cancel the permanent recognition/permission of the school.

The complaint was forwarded to the District Education Officer, Jhajjar to conduct an inquiry and submit inquiry report along with comments. Accordingly, the D.E.O., Jhajjar submitted the inquiry report on 24.03.2015 to the Directorate of Secondary Education whereby the allegations levelled by the complainant were found to be true.

Therefore, under the Rule 43 of the Rules, the school management i.e. the society was issued a notice of showing cause as to why the recognition/N.O.C. granted to their school upto 10+2 level might not be withdrawn/suspended from the next academic session 2016-17. The

management/society was also directed to submit reply/representation, if any, it wanted to submit to reach in the department within a period of 30 days.

In response to the show cause notice, no reply/representation to controvert the allegations levelled by the complainant was submitted by the society within the stipulated time of 30 days granted to society. Ultimately, the recognition of the school of the society was withdrawn by the under signed vide order dated 25.07.2015 w.e.f. 01.04.2016.

Thereafter, vide Review Application dated 24.08.2015, Sh. Sant Lal, Principal of the school had prayed that the recognition of their school might not be withdrawn and their submissions might be considered sympathetically. After affording an opportunity of hearing on 11.03.2016, the Director Secondary Education, Haryana had rejected the Review Application of the appellant and upheld the order dated 25.07.2015.


Feeling aggrieved by the aforesaid orders dated 25.07.2015 and 01.04.2016, the present appeal has been filed by the appellant on various grounds viz. (i) while taking recognition the appellant had supplied all the relevant documents alongwith the application, (ii) there was no residential building in the school premises, (iii) the Rule 30(1)x provided that the land of the school could be in two patches and the sizra of the land should be countersigned by the Tehsildar or by the Magistrate concerned, (iv) the complaint against the appellant had been disposed of by the Hon'ble Lokayukta, Haryana without ordering any further action, and (v) merely on the previous complaint the recognition of the school could not be withdrawn. Accordingly, the appellant prayed for setting aside the impugned orders.

While considering the appeal of the appellant, a report regarding the school was called from the field office. Following which, Smt. Jyoti Chaudhary, Dy. Director SCERT, Gurgaon inquired into the matter and submitted the report. In the enquiry report, it has been pointed out that no residential

building was found in the school campus. Two residential buildings are there alongwith the entry gate of the school and their exit is on the main road. The entry gate of one of these two residential buildings was found towards the gallery of the entry gate but it is locked for a long time. The enquiry officer has also pointed out that there is a dispute regarding partition of land between the brothers inter se.

As a sequel of above findings, I have come to the conclusion that the order dated 25.07.2015 was passed on two grounds that a wing of the school was far off from the main building and that a residential building was erected in the school or a part of school building was being used for residential purposes. While enquiries have revealed that the second allegation is unfounded, there is no specific rule that is violated in case of the first allegation. In view of this, the appeal of the appellant is accepted and the order dated 25.07.2015 is hereby set aside.

I order accordingly.




