1. यह कि श्री चरण सिंह, सहायक द्वारा श्रीमती मूर्ति देवी, जे0बी0टी0अध्यापिका, रा0मा0वि0, जजावन्ती, जीन्द के विकलांगता के आधार पर 58 से 60 वर्ष की सेवावृद्धि प्रदान करने से सम्बन्धित मामला अपने पास लम्बित रखकर उसे अनावश्यक तौर पर परेशान किया, जिसकी वजह से उक्त अध्यापिका द्वारा माननीय न्यायालय का सहारा लेना पड़ा जिसकी वजह से उक्त अध्यापिका को आर्थिक तथा मानसिक परेशानियों का सामना करना पड़ा।
2. यह कि श्री चरण सिंह, सहायक द्वारा श्रीमती मूर्ति देवी, का मामला अनावश्यक तौर पर निदेशालय में भेजा गया। जबकि इससे सम्बन्धित शक्तियां जिला शिक्षा अधिकारी के पास निहित है।
3. यह कि श्री चरण सिंह, सहायक द्वारा उक्त अध्यापिका को बिना वजह सेवानिवृत्त करवा दिया गया है। जबकि उक्त अध्यापिका द्वारा अपना पूर्ण सेवावृद्धि मामला मूल चिकित्सा प्रमाण पत्र समय से पहले उनके कार्यालय को प्रेषित कर दिया गया था। उसके बावजूद भी कर्मचारी का मामला अनावश्यक तौर पर लम्बित रखा।
4. यह कि श्री चरण सिंह, सहायक के विरुद्ध उक्त कर्मचारी से शिकायत प्राप्त होने उपरान्त श्री दिलबाग सिंह, संयुक्त निदेशक, मास्टर से मामले की जांच करवाई गई जिसमें जांच अधिकारी द्वारा उक्त लिपिक को मामले में देरी करने के लिए पूर्ण रूप से दोषी पाया गया।

कर्मचारी द्वारा दिनांक 17.07.2014 को चार्जशीट का जवाब दिया गया। तदोपरांत श्री वी0पी0 बतरा, सेवानिवृत्त, आई0ए0एस0 को निदेशालय के पत्र दिनांक 06.07.2015 द्वारा जांच अधिकारी नियुक्त किया गया। जांच अधिकारी ने अपनी जांच रिपोर्ट दिनांक 15.01.2016 को निदेशालय में दी जिसमें कर्मचारी पर लगे आरोप नं0 1, 3 व 4 कथित हद तक साबित होते हैं। परन्तु आरोप नं0 2 साबित नहीं होता। आरोपित कर्मचारी को नियमानुसार, पत्र दिनांक 15.02.2016 को जांच रिपोर्ट की प्रति प्रतिवेदन देने के लिए भेज दी गई। और दिनांक 24.06.2016 को निजी सुनवाई का अवसर प्रदान किया गया। कर्मचारी ने दिनांक 24.06.2016 को निजी सुनवाई के दौरान he admitted his fault to the extent that it was to be done by other clerk and he was indirectly responsible. इसके अलावा कोई भी रोग प्रस्तुत नहीं किया।
