The current rationalized distribution of posts is based on the students' enrolment as on 30.09.2015. Upon publication of the rationalized post allocation some schools approached the HQ, that their posts have been wrongly declared surplus. When we examined these cases, it has been found that the Principals/Head masters concerned sent a wrong/ incomplete data to HQ despite numerous correspondences alerting them to send accurate data. These heads of institutions, on the one hand, deprived the students from an opportunity to get teachers, on the other hand, they created unwarranted conditions for the teachers who had not completed five years tenure in their zones of posting and they were willing to continue on their post prior to 06.08.2016. This carelessness on the part of these heads of institutions is highly deplorable. The department is mooting the idea of mentioning this fact in their ACRs/APARs.

However, for doing justice to the students and the teachers displaced under compelling circumstances it has been decided that posts be allocated to such schools as per the actual students enrolment as on 30.09.2015. It has further been decided that the teachers, who had not completed five years of stay in that zone and were not willing to participate in the general transfer drive of PGTs, be restored to such posts which were declared surplus due to faulty data, if such teachers are willing to be restored.




