

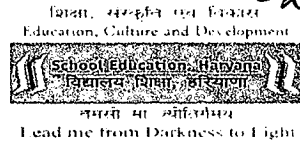

TERMS & CONDITIONS:-

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. However, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.

5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in the same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the Appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student of elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.

Memorandum

Subject:- Regarding allocation of posts of PGTs .

Reference office memo no 4/33-2011 SE (4) dated 05.07.2017 vide which rationalized allocations of posts of PGTs was issued for every Government High and Senior Secondary Schools for the year 2017-18.

The matter of determining the teacher surplus has been deeply examined in view of the provisions of Teachers Transfer Policy, 2016 notified on 29.06.2016 and on 01.06.2017. The policy provisions and the technical deliveries determine the steps declaring a teacher surplus are as under:-

1. First of all, clear vacant position will be marked as surplus.
2. Still, if count is not satisfied then employees who are deemed eligible (who have completed more than 5 years stay in zone) will be marked surplus.
3. Still, if count is not satisfied then employees who are newly promoted to higher post but not relieved due to the reason giving no posting or posting given but not yet relieved.
4. Still, if count is not satisfied then employees who have voluntarily/forcefully participated in the drive. (This shall also include employees who are Assistant NCC Officer (ANO), suffering from 100% vision loss, 100% Locomotor disability for any reason, currently suffering from cancer and other diseases approved in transfer policy and who have voluntarily participated).
5. Still, if count is not satisfied then zonewise school wise stay is calculated and employee who is not otherwise eligible for transfer (except employees who are Assistant NCC Officer (ANO), suffering from 100% vision loss, 100% Locomotor disability for any reason, currently suffering from cancer and other diseases approved in transfer policy) and whose stay at present station is higher is considered for surplus.
6. Still, if count is not satisfied then Position of employees whose current type of appointment is contractual/ adhoc. Such employees relieved from school with reason for leaving "Surplus" (Employees having least stay will be surplus first).
7. Still, if count is not satisfied then only such protected employees are marked as surplus in the following sequence:-
 - a. Employees who are Assistant NCC Officer (ANO).

Whereas Sh. Rajender Kumar, Lecturer in Hindi, Govt. Sr. Sec. School, Kiwana (Panipat) was placed under suspension as FIR No. 424 dated 15.08.2009 U/S 306/509/109/341/120 B IPC was registered against him. He was placed under suspension on 06.11.2009 and charge sheet U/R-7 was issued vide order No. 16/10-2009 HRL (2) dated 19.03.2010/23.03.2010. Allegation was levelled against the incumbent that he has misbehaved and abused to Late. Kumari Neelam, Lecturer in English in the said school. He abetted the students of 10+2 class due to which Kumari Neelam, Lecturer came under depression and died. Sh. Rajender Kumar was arrested on 16.07.2009 and sent in judicial custody at Karnal.

Sh. V.P. Batra, IAS (Retd.) was appointed as inquiry officer to conduct the regular enquiry. The Enquiry Officer has submitted his report wherein, no charge has been established. Inquiry officer also reported that the criminal case will be decided by the Hon'ble Court and accordingly, the Hon'ble Court of Session Judge, Panipat has acquitted the incumbent vide order dated 25.05.2012. The Cr. Misc. appeal No. A-626-MA of 2012 Daya Nand Vs. State of Haryana filed in the Hon'ble High Court against the order of Session Court, Panipat. The same was dismissed on 12.09.2013. The operative part of the order is as under:-

"In view of the facts mentioned above, it is clear that the prosecution has failed to prove its case before the trial court that the deceased committed suicide due abetment. Accordingly, there is no merit in the contention raised by the learned counsel for the

applicant and well reasoned finding recorded by the trial court and application for leave to appeal is dismissed.”

In view of the facts of the case, the charge-sheet issued vide order No. 16/10-2009 HRL (5) dated 19.03.2010/23.03.2010 is hereby filed and the suspension period of Sh. Rajender Singh, Lecturer Hindi, Govt. Sr. Sec. School, Kiwana (now working Govt. Sr. Sec. School, Panipat (Tehsil Camp) for the period from 16.07.2009 to 26.02.2013 is hereby treated as duty period for all intents & purposes.

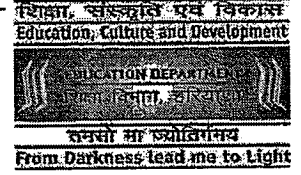


