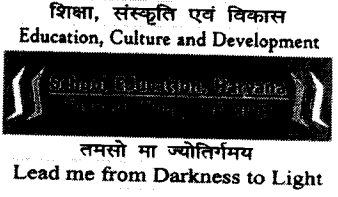

Whereas, during the 2nd Transfer Drive a few PGTs (*mentioned at Sr. No. 1 to 6 in table below*) duly posted during previous phase before 21.12.2016 have been included inadvertently by the system automatically. Even when these teachers did not give preferences, yet the system erratically and forcibly included them in the transfer process. Therefore, it has been decided to rollback the transfer orders in respect of following teachers generated on 21.12.2016 with immediate effect and they are allowed to continue at their present respective places of posting.

Further, some teachers (*mentioned at Sr. No. 7 to 43 in table below*) were marked in the same school by the system even though these teachers participated in the transfer drive by duly filling their preferences of stations. These teachers were marked in the same school due to a logic of 6 & 7 zone or mewat district cadre, as the case may be. Though they are fairly correctly posted if we interpret the software functioning as per above logics, yet to accommodate these teachers from the satisfaction stand point of the policy, that too when the preferred stations of these teachers are still available vacant, a decision has been taken to allot these vacant stations to these teachers mentioned against their names with immediate effect.
