

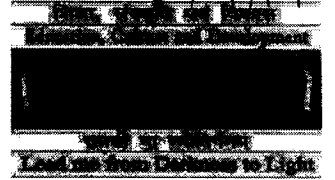

Whereas Sh. Sunita Devi, PTI, Arya Kanya Mahavidyalaya, Narwana, (Jind) had filed CWP No. 21255 of 2014 in Hon'ble Punjab and Haryana High Court, Chandigarh for praying therein for quashing the impugned relieving order dated 26.09.2014 passed by the Respondent No. 4 and further directing the Respondents to re-instate her back in service on the post of PTI in the abovesaid school or adjusted to any other school and Grant her all other consequential benefits for the services rendered by her with continuity of service.

The said petition was disposed of by the Hon'ble Punjab & Haryana High Court, Chandigarh on 20.01.2017 with the following directions:-

"Pursuant to the order dated 04.11.2016 learned State Counsel submitted that if the petitioner approaches the competent authority by filing necessary affidavit furnishing the service particulars and details, the petitioner would be accommodated in any one of the vacancy. Thus, the petitioner is permitted to approach the competent authority by furnishing service particulars and representation. If such representation is given by the petitioner, the competent authority is directed to consider the same. The above exercise shall be completed within a period of 6 weeks'. The petitioner is permitted to submit representation within a period of one week from today.

Accordingly, petition stands disposed of.

That in compliance of the aforesaid directions of the Hon'ble High Court, the petitioner has submitted his representation on 25.01.2017 and requested to adjust her in S.D. Senior Secondary School, Jind against vacancy. She has also submitted an affidavit alongwith her representation stating therein that her date of appointment is 02.02.1995. She is working as PTI in Arya Kanya Sr. Sec. School, Narwana (Jind). There is no departmental inquiry/complaint is under consideration against her. She has also submitted in her affidavit that the facts stated by her are true and correct and nothing has been concealed therein.

The Department has sought information regarding vacancies of the PTI teachers from the District Education Officer, Ambala, Jind, Kaithal, Hisar, Karnal and Kurukshetra and the detail of the same was brought into the notice of Hon'ble High Court at the time of hearing of the said CWP.

After considering the request of the petitioner and in pursuance of the directions dated 20.01.2017 passed by Hon'ble High Court in CWP No. 21255 of 2014 titled as Smt. Sunita Devi versus State of Haryana & others, it has been found that her request is liable to be accepted.

Therefore, the petitioner, Smt. Sunita Devi, PTI, Arya Kanya Mahavidyalaya, Narwana, Jind is hereby adjusted in S.D. Sr. Sec. School, Jind against vacant post with immediate effect.

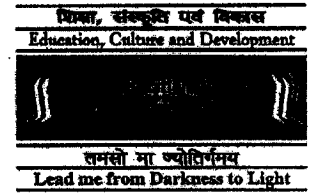
