



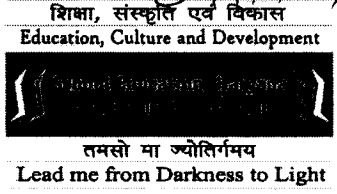

9. Concerned DDO is also directed to update and approved MIS data of the official at your own level within three days positively.
