

Whereas Sh. Ramesh Chand, Clerk, O/o GGSSS Aurangabad (Faridabad) was placed under suspension vide this office order No. 5/88-05 HRME (3) dated 21.11.2005 due to registration of FIR No. 257 dated 21.09.2005 against him under section 363, 366 IPC in Police Station, Hathin and further he was chargesheeted vide this office order No. 5/88-2005 HRME (1) 2446 dated 22.05.2013 on the following charges:-

1. यह कि जिला शिक्षा अधिकारी, फरीदाबाद के पत्र दिनांक 13.10.2005 के अनुसार जैसा सविता के पिता श्री ग्यासी राम गांव कोण्डल थाना हथीन ने प्रार्थना पत्र दिया कि श्री रमेश चन्द, लिपिक उसकी लड़की सवित को गांव कोण्डल से बहलाफुसला कर लालच देकर इलाज के लिए बालाजी ले गया। लड़की के पिता ने थाना हथीन में एफ0आई0आर0न0 257 दिनांक 21.09.2005 धारा 363,366 आई0पी0सी0 के तहत दर्ज करवाई।
2. प्रधानाचार्य, रा0क0व0मा0वि0, औरंगाबाद के पत्र क्रमांक 278/05 दिनांक 04.10.05 अनुसार श्री रमेश चन्द का अर्जित अवकाश आवेदन, कोई अनजान व्यक्ति दिनांक 05.09.2005 को विद्यालय इन्चार्ज को दे गया तथा उस समय से कर्मचारी अनुपस्थित चल रहा है।

He replied to the chargesheet on 23.07.2013 through Deputy Superintendent, Jail, Gurgaon in which he stated that at present he is in jail and has filed an appeal in the High Court and after releasing, from the jail, he will be present in the office.

Deputy Superintendent, District Jail, Gurgaon, has informed vide his letter No. 7786, dated 29.07.2013 that the above said prisoner is sentenced life imprisonment in case FIR No. 244 dated 21.07.2009 under Section 302 IPC Police Station, Sec.5, Gurgaon and he was convicted since 21.09.2009 in District Jail, Gurgaon.

Thereafter, in view of the facts stated above and after perusing the relevant record, the information provided by the Dy. Superintendent, Jail vide letter dated 23.07.2013, the undersigned is provisionally of the view that Sh. Ramesh Chand, Clerk is not liable to be retained in the service. As per instruction issued by Chief Secretary, vide letter No. 4819-G-II-57/11919 dated 08.07.1957. The relevant extract of the same is reproduced as under:-

"If a Govt. Servant is convicted of charges of involving moral turpitude, he should be dismissed or removed from Govt. Service and the filing of the appeal should not debar the authority from inflicting a suitable punishment as provided in Proviso (b) to sub rules (2) of Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987."

Thus, the competent authority has to take decision against an employee on the basis of conduct, which led to his conviction. However, before taking final decision, a show cause notice was issued to Sh. Ramesh Chand, Clerk vide office order No. 5/88-2005 HRME (1) dated 14.08.2014 and was given an opportunity of show cause, as to why not his services be dismissed.

In response to the notice, Sh. Ramesh Kumar submitted his reply to show cause notice and stated that he is in jail and will appear in the office after releasing from the jail.

After pursuing the reply of Sh. Ramesh Kumar, it has been found that nothing more has stated by him in reply to the show cause notice, therefore, in view of the above mentioned facts of the matter, I being competent authority, confirm the proposed show cause notice dated 14.08.2014.

Ordered accordingly.
