



Whereas, Dr. Paramjit Sharma, District Education Officer, Kurukshetra was placed under suspension vide order dated 22.08.2016. She filed a Civil Writ Petition No. 4049 of 2017 in the Hon'ble Punjab and Haryana High Court and prayed therein to quash the order dated 22.08.2016 whereby she was placed under suspension and further prayed for directing the respondents to pay full pay and allowances to the petitioner after 14.11.2016. This writ petition was disposed of by the Hon'ble Court on 01.03.2017 with the following directions.

“Learned senior counsel for the petitioner undertakes to supply a copy of the petition to the learned State counsel during the course of the day. He further states that in this connection the petitioner has got issued legal notice (Annexure P-35) to the respondents and at this stage she would be satisfied if the legal notice is decided by the respondent No.1 within any reasonable time.

I find this to be a fair submission. Keeping in view the plight as portrayed, I deem it appropriate to dispose of this petition with a direction to the respondent No.1 to decide the said legal notice of the petitioner by passing a speaking order thereon. More than five months have elapsed since the suspension order was passed, therefore, it is directed that in case no decision is taken on the legal notice in conformity with the above direction on or before 31.03.2017 the suspension of the petitioner would be deemed to be revoked.”

In compliance of the above directions of the Hon'ble Court the legal notice of the petitioner (Annexure P-35) is considered and it has been observed that in her legal notice the petitioner mainly contended:-

(1) A period of more than 90 days has elapsed but no formal charge sheet has been served upon her. By virtue of provision of rule 5(1) her suspension stands revoked immediately on the expiry of 90 days and therefore entitled full pay and allowances after 14.11.2016.

(2) Second ACP scale admissible to the petitioner and due to her has not been paid till date which should be granted to her with all arrears.

(i) A T.A. bill amounting to Rs. 80,000/- for the period from 2014 to 27.04.2016 when she inspected the schools as per order of the Directorate has not been paid to the petitioner.

(ii) A T.A. bill amounted to Rs. 2,52,000/- is also due towards the District Education Officer, Ambala for the period from 2008 to 2012 has also not been paid.

That so far as issuing of formal chargesheet to the petitioner is concerned, she has now been chargesheeted under rule -7 of the Haryana Civil Services (Punishment & Appeal) Rules 2016 vide Order No. 25/65-2016 HRG-1(3) dated 30.03.2017 as per requirement of the Hon'ble Court order dated 01.03.2017 before 31.03.2017, so decision regarding treating her suspension period as period spent on duty or otherwise will be decided after concluding the Departmental proceeding against her.

So far as the decision regarding the second ACP to the petitioner is concerned the same is presently under consideration and if she is found eligible under the Rules for the second ACP, the same will be released to the petitioner.

So far as T.A. bill amounting to Rupees 20,520/- for the period from 02.12.2014 to 04.12.2015 for the inspection of the schools is concerned, that has been released to the petitioner vide order no. kw 12/54-2008 Admn(2) dated 19.02.2016 and the necessary sanction has been issued vide order no. kw 12/54-2008 Admn(2) dated 22.03.2017 regarding the bill for the period from 27.12.2014 to 01.01.2015 and from 28.01.2015 to 30.01.2015.

That the bills submitted by the petitioner for sanctions relate to 02.12.2014, 11.03.2015, 06.05.2015, 28.05.2015, 17.08.2015 to 20.08.2015, 24.09.2015, 28.09.2015 to 30.09.2015, 14.11.2015 to 15.11.2015 and 23.11.2015 to 27.11.2015, but she did not submit the necessary approval from the competent authority for the above tour programmes despite repeated reminders from the Department and therefore the bills could not be sanctioned to her.

That so far as T.A bill amounting to Rupees 2,52,000/- for the period from 2008 to 2012 is concerned, this amount relates to the period of office of District Education Officer, Ambala. In order to settle the same, District Education Officer, Ambala was asked vide letter dated 29.01.2017 by enclosing her representation dated nil regarding T.A. claim for the said amount. Now District Education Officer, Ambala has informed that she had not got the approval of the competent authority for the journey/tour programme performed by her. As per provision made in Rule 2.35 of Punjab Civil Services Rules,

Vol. III, it is mandatory to get the approval of the competent authority for performing a tour. As per Rule 2.2 of the ibid Rules, Head of the Department is competent to sanction tour and as per Finance Department letter no. 2/1(4)-80-2FR-II dated 25.5.1989, the right of a Government employee to traveling allowance including daily allowance, is forfeited or deemed to have been relinquished if the claim for it is not preferred within one year from the date on which it becomes due.

As per the available record, it is revealed that the journey performed by the petitioner while being posted as Deputy DEO, Ambala were not approved by competent authority. Also, she has not submitted the due claim within the prescribed time limit and no documentary proof has been submitted by her in support of her claim. In a nutshell, the petitioner, while performing her journey, if any, did not have any approval of the competent authority under whose supervision she worked and as such she did not perform any valid journey for the impugned period. There is no substance in her claim of T.A. at this highly belated stage and the same is liable to be rejected on these scores in view of the FD instruction dated 25.05.1989.

Ordered accordingly.
