



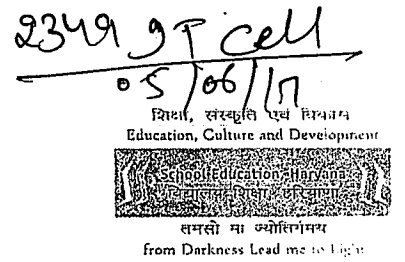

**ORDER**

Consequent upon the orders dated 18.10.2016 passed by the Hon'ble High Court in CWP No. 8689 of 2016 and on the recommendation of Haryana Staff Selection Commission (HSSC), Sector-2, Panchkula conveyed vide their Memo No. Haryana Staff Selection Commission/Confid. Recomm/Edu/2016/917 dated 02.11.2016, the Governor of Haryana is pleased to appoint Sh. Vikram Singh S/o Sh. Satyapal Singh, Village Khatoti Khurd, P.O Hamidpur, Tehsil Narnaul, District Mahendergarh as Post Graduate Teacher (PGT) in History (HES-II) in the pay band of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible from time to time w.e.f. 14.12.2013 and also allowed notional benefits from his date of appointment to his actual date of joining which would include the benefit of pay fixation, increments, seniority and all other consequential benefits. He is directed to join at the place of posting as mentioned below:-

**Terms and conditions:-**

1. The benefit of ante-date appointment w.e.f. 14.12.2013 will be admissible to him only for notional pay fixation and seniority and actual financial benefits will be admissible to him from the date he joins duty as **PGT History**.
2. He is appointed purely on temporary basis. This appointment is against temporary post and his confirmation against substantive post shall be considered on the basis of his seniority and record of service as and when such post is available.
3. He shall have to take an oath of allegiance to the Constitution of India.
4. In case He is married, he shall produce a certificate, before joining duty, to the effect that he has only one living spouse. If he has more than one living spouse, he shall be eligible for appointment to the post offered only after the Government is satisfied that he has special ground for doing so, and exempt himr from this condition.

5. He shall not be allowed to apply for any post outside the department for a period of at least five years.
6. He shall not claim seniority on the basis of this order. His inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time later on.
7. He shall be on probation for a period of two years. The period of probation can be extended for a period not exceeding one year, if considered necessary.
8. In the matters, not specifically mentioned in this communication, he shall be governed by the Punjab Civil Services Rules as applicable to Haryana Government Employee and such orders/ instructions as may be issued by the Government from time to time.
9. In case of reserved category candidate, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/Backward Class and ESM Category Certificate. If the verification reveals that the claim of belonging to SC/ST/BC and ESM, as the case may be, is false then his service will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
10. Candidate is hereby directed to produce his original certificates of academic qualifications, and other relevant certificate to the District Education Officer concerned alongwith photostat self- attested copies.
