

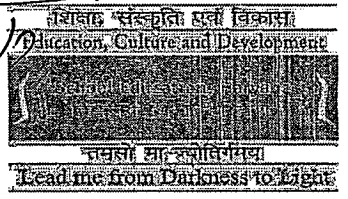

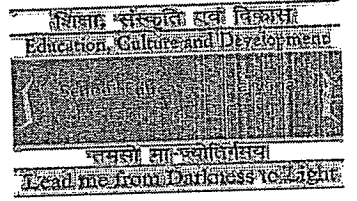
1. श्री रणबीर सिंह, सहायक, कार्यालय जिला मौलिक शिक्षा अधिकारी गुरुग्राम अब डाईट गुरुग्राम को JBT अध्यापकों से सम्बंधित स्थापना शाखा (E-2) का कार्य सौंपा गया था। जब भी इनकी शाखा से सम्बंधित कार्य की अधिकता या उसकी जरूरत होती थी तो कर्मचारी जानबूझकर छुट्टी कर लेता व आवेदन बाद में प्रस्तुत करता। हाल में हुए दिनांक 17.09.2016 को JBT अध्यापकों के स्थानांतरण के समय में कर्मचारी ने 19.09.2016 से 21.09.2016 तक कार्यालय में उपस्थित न होकर अपनी छुट्टी Mail द्वारा कार्यालय में भेजी जबकि अधिकारी द्वारा यह स्पष्ट आदेश थे कि सभी कर्मचारी को छुट्टी स्वीकृत करवानी है या जरूरी होने पर दूरभाष पर अधिकारी को सूचित करना है जबकि कर्मचारी द्वारा ऐसा नहीं किया गया। अतः अधिकारी के आदेशों की अवहेलना करके अपने आप को दोषी बनाया है।
2. अधिकारी द्वारा आदेश पुस्तिका में JBT अध्यापकों के स्थानांतरण का कार्य पूरा करने के आदेश दिए गए तो कर्मचारी ने आर्डर बुक में नोट करते हुए यह लिख दिया कि एक अतिरिक्त कर्मचारी सहायक के रूप में दिया जाए और बिना मैडीकल सर्टिफिकेट के 10 दिन की मैडीकल छुट्टी, आदेश पुस्तिका में लिख डाली। जिसके कारण JBT अध्यापकों के अन्तर जिला स्थानांतरण में नियुक्ति पत्र जारी करने में तथा अध्यापकों के कार्यग्रहण/कार्यभार मुक्ति के कार्य में बाधा पहुंची, इस प्रकार कर्मचारी ने सरकारी कार्य में बाधा उत्पन्न करके अपने आप को दोषी ठहराया है।
3. कर्मचारी द्वारा अपनी शाखा से सम्बंधित कार्य ठीक समय पर न करके, वर्षों/महीने तक पैडिंग पड़े रहने देना, जिसके कारण अध्यापकों को मानसिक परेशानी हुई तथा वित्तीय हानि के साथ, कोर्ट केसों की सम्भावना बनती है उदाहरण के तौर पर श्री बिशन स्वरूप, JBT अध्यापक, रा0प्रा0पा0 मउ लोकरी को काफी परेशान किया गया, जिसकी शिकायत की प्रति इस कार्यालय के क्रमांक ई-3/2016/1156 दिनांक 07.10.2016 के तहत आपको भेजी जा चुकी है।
