



If she has more than one living spouse, she shall be eligible for appointment to the post offered only after the Government is satisfied that she has special ground for doing so, and exempt her from this condition.
- 5. She shall not be allowed to apply for any post outside the department for a period of at least five years.

- 12. She shall be governed by the Haryana State Education School Cadre (Group-B) Service Rules-2012.
- 13. If at any time during the course of his temporary appointment, she desires to resign, then in such eventuality, she shall be required to

give one month's notice or forfeit, in lieu thereof, her one month's salary including allowances etc.

- 18. The appointment will be subject to the condition of good moral character as the verification report is awaited from the District Magistrate, concerned and Superintendent of Police, concerned.
- 19. The appointment is subject to the outcome of vigilance enquiry or departmental enquiry.
