

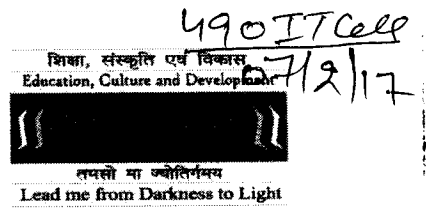

**Subject:- Permission for up-gradation/permanent recognition of private schools.**

Kindly refer to the subject cited above.

It is intimated that during inspecting the files regarding permission/up-gradation/permanent recognition of private schools, it has been observed that generally self attested documents are being attached related to the ownership of land. It does not seem correct verification of the relevant documents. It has now been decided that in future the applicant schools may be directed either to attach original documents regarding the ownership of land duly signed by SDM/Tehsildar in ink or verification of land verified by the revenue authority or attach attested copy of the original by a Gazetted Officer. Photocopy of the attested copy shall not be permitted in any case. This precedent is required to be followed in all cases e.g. documents related to pledged money, building norms, fire safety norms, health norms and DTP report etc. This may please be brought to the notice of public by broad publicity in local as well as national newspaper.
