

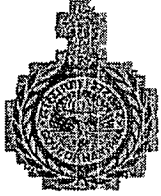

Whereas Shri Zile Singh [024424], Principal, GSSS Kalsora was charge-sheeted under rule-8 Hayrana Civil Services (P&A) Rule 1987, vide this office order dated 06.09.2012 and the following charges were levelled against him:-

“यह है कि श्री जिले सिंह द्वारा श्रीमती गीता को पात्र न होते हुए भी दिनांक 06.09.2006 को राउजोवि० नगला मेघा में हिन्दी अध्यापिका (अतिथि) के पद पर नियुक्ति प्रदान की है, जबकि प्रार्थी द्वारा अप्रैल 2010 में हिन्दी इलेक्टिव की परीक्षा पास की है।”

In response to this, Shri Zile Singh replied to the charge sheet on 16.10.2015 and denied all the charges levelled against him. The reply filed by him was found unsatisfactory. Therefore, a punishment of stoppage of two increments without commulative effect was inflicted upon him vide order dated 30.11.2015.

Thereafter, Shri Zile Singh filed an appeal before the undersigned against the order dated 30.11.2015 with request to drop the chargesheet dated 06.09.2012. On the above said appeal, the comments of District Education Officer, Karnal were sought on 22.07.2016 in the matter. The District Education Officer, Karnal has given his comments on 07.11.2016, wherein it was stated that Smt Geeta Devi was intially appointed as Guest Teacher at GSSS Daha instead of GHS Nagla Megha. Although, she was not eligible for the post of Hindi Teacher (Guest) as she was not having requisite qualification. It has further stated in the aforesaid comments that the merit list was prepared on 22.12.2005 by Sh. Sushil Kumar, the then DDO of GHS Nagla Megha, PGT Biology presently posted as DSS in the O/o District Education Officer, Karnal. In this way, Shri Zile Singh has not enegaged Smt Geeta Devi, Hindi Teacher (Guest) in GHS Nagla Megha on 06.09.2006.

I have gone through the contents of the reply to chargesheet, considered the submissions made by Shri Zile Singh and keeping in view the report of District Education Officer, Karnal, the charge sheet dated 06.09.2012 against Shri Zile Singh is hereby dropped.

I pass an order accordingly.

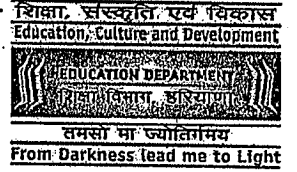

2. इसके द्वारा श्री मोहम्मद याकूब खां, से उनके द्वारा इस ज्ञापन की प्राप्ति की तिथि से पन्द्रह दिन की अवधि के भीतर लिखित रूप में बताने की अपेक्षा की जाती है कि वे सभी आरोपों या उनमें से किसी को स्वीकार करते हैं या नहीं। उन्होंने क्या स्पष्टीकरण या प्रतिवेदन, यदि कोई हो, प्रस्तुत करना है और क्या वे व्यक्तिगत रूप में अपनी सुनवाई चाहते हैं।
3. इसके द्वारा श्री मोहम्मद याकूब खां, को आगे सूचित किया जाता है कि यदि वे अपने लिखित कथन को तैयार करने के प्रयोजन के लिए सुसंगत सरकारी अभिलेखों को देखना चाहते हैं तो उन्हें निदेशक विद्यालय शिक्षा हरियाणा, पंचकुला के कार्यालय में उनके साथ पहले समय नियत करने के बाद, किसी कार्य दिवस को, उनका निरीक्षण कर सकते हैं। फिर भी यह बताया जाता है कि उन्हें केवल ऐसे ही दस्तावेज दिखाये जायेंगे, जोकि निदेशक विद्यालय, शिक्षा हरियाणा, पंचकुला के पास हैं और जो मामलों के साथ पूरी तरह से सुसंगत हैं। यदि सरकार की राय में उन्हें किन्ही दस्तावेजों को दिखाने की अनुमति देना वांछनीय नहीं है तो उन्हें यह दस्तावेज दिखाने से इन्कार कर दिया जायेगा। यदि श्री मोहम्मद याकूब खां, ऐसे किसी अन्य सुसंगत अभिलेख को देखना चाहते हैं जो निदेशक विद्यालय शिक्षा हरियाणा, पंचकुला की अभिरक्षा में नहीं है तो उनका निरीक्षण करने की जिम्मेवारी उनकी अपनी होगी। फिर भी श्री मोहम्मद याकूब खां, लिपिक, कार्यालय जिला मौलिक शिक्षा अधिकारी नूंह, (मेवात) को यह बात स्पष्ट की जाती है कि उनके द्वारा उक्त दस्तावेज का निरीक्षण न किया जा सकना उनके लिखित कथन को भेजने में देरी के लिए वैध आधार नहीं माना जायेगा और यदि लिखित कथन निम्नहस्ताक्षरकर्ता को निर्दिष्ट अवधि के भीतर प्राप्त नहीं होता है तो यह समझा जायेगा कि उन्हें इस सम्बन्ध कुछ भी प्रस्तुत नहीं करना है।

1. यह कि जिला मौलिक शिक्षा अधिकारी, नूंह द्वारा दी गई शिकायत के अनुसार आपके पास CM Window तथा स्टेनो शाखा का चार्ज है। शाखा के कार्य को आप पूरी तरह से नहीं निभा सके। जिसके कारण जिला शिक्षा अधिकारी तथा जिला मौलिक शिक्षा अधिकारी नूंह के कार्यालय की कई शिकायतें Red Zone में चली गई है। जिसके कारण उन्हें काफी जिल्लत झेलनी पड़ी जो आपके स्तर पर घोर कोताही है।

इसके अतिरिक्त आपका व्यवहार अपने साथियों के साथ भी ठीक नहीं रहा। श्री सुमेर सिंह, उप जिला शिक्षा अधिकारी नूंह की मेज से फाइल गुम करने का भी आरोप है। जिसके कारण जिला मौलिक शिक्षा अधिकारी नूंह को भी प्रताड़ित होना पड़ा। (कार्यालय में से कई दस्तावेज गायब कर दिये) कम्प्यूटर के password को भी नहीं बताया।
