Whereas Shri Prem Singh [028544], the then Block Elementary Education Officer, Gulha Cheeka [6732] (Kaithal) now posted as Block Education Officer [5025], Gulha Cheeka (Kaithal) was charge-sheeted under rule-8 Hayrana Civil Services (P&A) Rule 1987, vide this office order dated 06.09.2012 and the following charges were levelled against him:-

*“यह कि श्री प्रेम सिंह द्वारा subject combination न होते हुए भी श्री अमृत पाल को दिनांक 21.12.2005 को राठवा0भा0वि0 भागल में एस0एस0 अध्यापक (अतिथि) के पद पर नियुक्ति प्रदान की। अतः श्री प्रेम सिंह ने अपनी शक्तियों का दुरुपयोग करके सरकारी कर्मचारी (आचरण) नियम 1966 के नियम, 3.(1), (ii) तथा (iii) की उल्लंघना की।”*

He has given the reply to the chargesheet and denied the allegations levelled against him. The reply given by him was found unsatisfactory. Therefore, a punishment of stoppage of two increment without cumulative effect was inflicted upon him vide order dated 30.11.2015.

Thereafter, Shri Prem Singh filed an appeal dated 29.12.2015 against the order dated 30.11.2015 with request to set aside the order. Accordingly, after considering this appeal, an opportunity of personal hearing was granted to him on 20.07.2017. During the course of personal hearing, he reiterated the facts submitted in his earlier reply to the chargesheet and also stated that subject combination of Shri Amrit Pal, SS Master was in order at the time of his engagement as Guest Faculty. He also submitted that Sh Amrit Pal has passed BA 2<sup>nd</sup> and BA 3<sup>rd</sup> with History as additional subject prior to his appointment.

I have gone through the contents of the reply of charge sheet and considered the submissions made by Shri Prem Singh and found that the engagement of Sh Amrit Pal, SS Master (Guest Faculty) was in order. It was also found that appellant have submitted the relevant documents earlier also but the same were ignored. Keeping in view the reply to charge sheet and submission made by him during personal hearing, I do not find any infirmity in the appointment of guest teacher. Therefore, I drop the charge sheet and set aside the order dated 30.11.2015 accordingly.



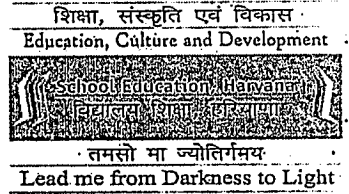

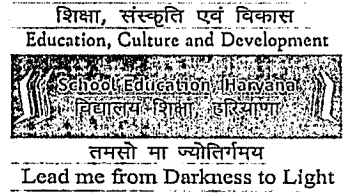
