



Some of the PGTs who participated in the transfer process complained that their merit points got violated during allocation of stations in the 2<sup>nd</sup> drive by the system. Upon examination of their cases it has been found that due to system error/bug the merit of some cases have been violated. As other teachers had already been given stations by the system so for accommodation of the aggrieved ones it was not possible to give the same stations without unleashing a chain/ cascading effect on the settled or joined PGTs. So to avoid such situation, these PGTs have been accommodated in the available vacancies. At the same time, there are some teachers who have been allotted unsuitable/ unopted /unmerited stations in the anywhere in state category, while the stations were available in the vicinity of their options.

Accordingly following PGTs are hereby reallocated stations mentioned against their names.







Whereas Sh. Surender Verma, Principal, GSSS Dalamwala (Jind) was charge-sheeted under Hayrana Civil Services (P&A) Rule 1987, Rule -8 vide this office order dated 31.08.2016 and the following charges were levelled against him:-

*“यह कि राजकीय वरिष्ठ माध्यमिक विद्यालय, कालवा (जीन्द) में बनी कम्प्यूटर लैब के लिए जिला शिक्षा अधिकारी के कार्यालय द्वारा 7,38,000 रु० की ग्रांट प्राप्त हुई थी जिस ग्रांट का प्राचार्य, रा०व०मा०वि० कालवा, जीन्द द्वारा उचित तरीके से प्रयोग नहीं किया गया अर्थात् सरकारी पैसों का दुरुपयोग किया तथा इस कार्य हेतु प्राचार्य द्वारा बनाई गई कमेटी को किसी भी प्रकार की कोई सूचना नहीं दी। प्राचार्य ने लैब में प्रयोग होने वाला सारा सामान स्वयं ही खरीदा तथा सामान खरीद की फर्जी रसीदें देकर बिलों का भुगतान करवाया।*

*कम्प्यूटर सामान को बाजार भाव से अधिक कीमत पर खरीदा गया तथा सामान की खरीद अलग-2 स्थानों से जैसे पिल्लूखेडा मंडी, जीन्द व दूरस्थ जिला फतेहाबाद से की गई है जो कि जीन्द जिला से करीब 200 किलोमीटर दूर स्थित है। प्राचार्य ने इन दुकानदारों के मिलीभगत के चलते सरकारी पैसे को हड़पने का काम किया है।*

*कमेटी के किसी भी सदस्य के बिलों पर हस्ताक्षर नहीं है और न ही कमेटी के सदस्यों का खरीद बारे अवगत करवाया गया है। कमेटी के सदस्यों को गुमराह रखा गया है। इस कार्य में एस०एस०ए० के जे०ई० की संदिग्ध भूमिका है। इससे सिद्ध होता है कि श्री सुरेन्द्र वर्मा, प्राचार्य ने अपने पद व शक्तियों का दुरुपयोग किया है तथा सरकार से प्राप्त होने वाली सरकारी राशि का भी दुरुपयोग किया है।”*

He replied to the charge sheet on 20.09.2016 and refused all the charges levelled against him. However, during personal hearing on 06.12.2016, he admitted his mistake that few deficiencies were made by him while constituting of committee and the quotation made by the shopkeeper should be countersigned. He also admitted that quotation should also be got countersigned by the committee member which was not happened unknowingly. In addition to this, he also admitted that cement was used in lesser quantity in violation of instruction given by JE O/o SSA unknowingly.

From the perusal of official record and copy of the charge sheet of Sh. Surender Verma, Principal, GSSS Dalamwala (Jind), it shows that certain laxity and dereliction of duty on part of Sh. Surender Verma, Principal, GSSS Dalamwala (Jind) cannot be denied. It is also against the service norms that being Principal of the school, he does not have any knowledge about Rules/Instructions. It is clear from the above facts that Sh. Surender Verma, Principal, GSSS Dalamwala (Jind) committed the above irregularities intentionally and due to lack of knowledge regarding Rules and Govt. instructions which is expected from every Govt. employee who is holding the administrative post.

I after going through the contents of the reply of chargesheet and submissions of Mr. Surender Verma and keeping in view of his acceptance regarding irregularities during the course of hearing, a penalty of stoppage of one annual increment without cumulative effect is inflicted upon him which will be commensurated with the irregularities committed by him.
