Order No. 13/31-2016 PGT-II (3) Dated, Chandigarh, the 11.07.2017

Whereas in CWP No. 2299 of 2016 titled as Amin Khan Vs. State of Haryana and others is claiming to reconsider the grant continuity of service without back wages, to the petitioner from the date of relieving till his re-instatement in service, in view of the circular letter dated 25.11.2002 as well as guidelines dated 24.11.2003 as the similar service benefit has already been extended to his similarly situated employees of the respondent department and also to re-fix his pay notionally, as has been done in the cases of other co-employees- vide office orders dated 18.09.2008, 14.12.2011, 17.09.2012 and 28.05.2013 without any monetary benefit.

After receiving said writ petition, the case of the petitioner has been examined carefully and it has been found that initially he was appointed on the post of Lecturer in Hindi on 89 days basis vide memo No. 6/11-1997 E-IV (4) dated 15.01.1997 and on the expiry of his contractual period of 89 days he was relieved from service on 20.04.1997.

The petitioner challenged said relieving order by way of civil writ petition No. 9296 of 2005 after the gap of 8 years and Division Bench of the Hon'ble Punjab and Haryana High Court vide order dated 31.05.2005 issued directions to the respondents to decide the claim of the petitioner by way of speaking order and in the event of request made by the petitioner is accepted by respondent necessary relief be granted to the petitioner within a period of one month.

That in compliance of above directions of the Hon'ble Court the claim of the petitioner was examined by the respondent department and he was allowed to join back on duty vide order dated 09.12.2005 but without benefit of continuity of service.

Now, the petitioner has also brought into notice that some Lecturer i.e. Sh. Virender Singh, Lecturer in Political Science, Sh. Rajesh Kumar in CWP No. 24279 of 2012 and Sh. Umesh Chander, Lecturer in Economics were granted the benefit of continuity of services and regularization thereafter. He has further stated that he was reinstated back in services on 16.12.2005 and working continuously thereafter in the department. Now, he is retired on 30.04.2017.

The services of Sh. Rajesh Kumar were regularized by the department vide order No. 13/267-2012 PGT-II (5) dated 13.05.2016.

Further, after taking into consideration of the advice of Chief Secretary Haryana dated 24.05.2017 in case of CWP No. 18246 of 2012 titled as Umrao Singh and others Vs. State of Haryana and others. The services of all the petitioners were regularized by the department. Sh. Virender Singh, Lecturer in Political Science was also granted the benefit of continuity in service vide office order No. 13/25-2004 E-IV (4) dated 25.03.2005 and presently granted the benefit of regularization of services on 04.07.2017.

After going through the entire facts of the case. I have come to the conclusion that the claim of the petitioner is genuine and is liable to be accepted. Thus, being similar situated, the same benefit should be given to him as has been granted to other similar situated persons. Thus, the petitioner is hereby granted the benefit of continuity of service w.e.f. 15.01.1997 and his services also regularized w.e.f. 01.10.2003 in the interest of natural justice. However, he will not be entitled for any financial benefits except the benefit of continuity in service w.e.f. 15.01.1997.
