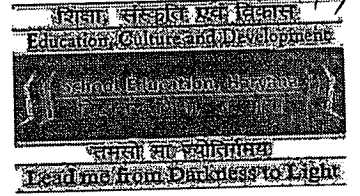

The Government has decided to provide Government job to Sh. Malkeet Son of Martyr Rohtash VPO Nangal Pathani Tehsil Kosli, District Rewari for the post of Clerk in SC Category vide order No. 5/34/2015- 1GSII dated 01.05.2017 keeping in view the government instructions No. 1/20/2013-1GS II, Dated 30/05/2014 and 27/08/2014 and Government instruction No. 42/164/2008-3 GS II, Dated 07/11/2013 regarding imposition of condition of SETC and as per service Rule etc. Accordingly, the following candidate is hereby appointed as Clerk (Group - 'C') in the pay scale of Haryana Civil Services Revised Pay Rule- 2016 under pay matrix Level-II Cell-I Rs. 19,900/- Basic Pay plus (+) usual allowances as sanctioned by the Haryana Govt. from time to time and is posted at place mentioned against his name with immediate effect on the terms and condition mentioned below:-

Note: His appointment is subject to the condition that DEO Rewari may ensure the Character certificate and all other documents regarding date of birth and all educational documents.

TERMS & CONDITIONS:-

1. His appointment is against a purely temporary post.
2. As per Govt. Notification No. G.S.R. 65/Const./Art. 309/2013 dated 08.11.2013; The Candidate shall have to qualify the State Eligibility Test in Computer Appreciation and Applications (SETC) within the probation period of two years. He shall not be entitled to earn any increment in his pay band and grade pay till he qualifies the said test, failing which the services of shall be dispensed with.
3. If at any stage, he desire to resign from his post, he will be required to give one month's notice or forfeit in lieu thereof, his salary including allowances for one month or for the period by which the notice falls

- short of one month. Such a notice will be given to him by the Directorate also if it is proposed to dispense with his services.
4. He will be required to take the prescribed oath of allegiance to the Constitution of India.
 5. In case he is married, he will produce the following certificate to Head of office:-“That he is not having more than one living spouse.”
 6. In case he is unmarried, he shall have to furnish a declaration to the effect that he will not have more than one living spouse.
 7. The employees possessing the following qualifications are exempted, from passing the State Eligibility Test in Computer Appreciation and Application (SETC): - (i) M.Tech/B.Tech (Computers), MCA, BCA or Diploma in, Computers from the recognized institutions e.g. Polytechnics,(ii) Basic Computer Literacy Certificate from any recognized center, established under the National Institute of Electronics 85, Information Technology (NIELIT) (erstwhile DOEACC Society), (iii) Haryana State- Certificate in Information Technology (HSCIT), from the Authorized Learning Centres (ALCs) of the, HKCL;, (iv) Candidates/employees who have already passed the SETC, and the same are valid at the time of joining the service., (v) Physically disabled candidates., However, these employees, with the exception of those, mentioned under sub-para (v) above, shall be required to clear the, 'typing speed' part of the State Eligibility Test in Computer, Appreciation and Applications (SETC).
 8. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the permission of higher studies.
 9. He will be required to produce the original certificates in support of his Educational qualifications and Date of Birth Certificate, Handicapped Certificate if applicable and Haryana Domicile certificate.
 10. He shall have to furnish fitness certificate from the Chief Medical Officer as required under Rule 3.1 of Punjab CSR Vol-I Part-I before joining his duties.
 11. If he have not been vaccinated within last twelve months he should have it done before reporting himself for duty.
 12. No TA/DA and joining time will be paid to him for joining this post.
 13. He will remain on probation for a period of two years, from the date of his appointment. The period of probation can be extended in accordance with the existing rule on the subject. For deciding his

performance during the period of probation, his work/conduct will be taken into consideration. If his work and conduct during this period is not found satisfactory, his services will be terminated without any notice.

14. His appointment is subject to the condition that He have passed Senior Secondary or its equivalent examination with Hindi.
15. His services will be governed by the Haryana Education Department sub offices Ministerial (Group-C) Services Rules, 1983 as amended from time to time.
16. His character and antecedents have been got verified and in case subsequently any adverse facts come to the notice of the State Govt. regarding his character and antecedents, his services are liable to be terminated.
17. His services will be governed under the New Pension Scheme of the Haryana Govt.

If the above terms and conditions are acceptable to him, he should report for duty to the office District Education Officer, Rewari within 15 days of the receipt of this communication along with relevant documents as stated above, failing which the offer will be cancelled.
